ASSOCIATE MEMBERSHIP OF CBROA

You are aware that your CBROA has passed a resolution in the General Body meeting held at Mysuru on 10th and 11th April 2023 to bring all the family pensioners as well as the spouses of our members to the fold of CBROA by enrolling them as Associate Members.

While we are extending assistance to the spouse of the deceased, in most of the cases, women, we noticed that after the demise of their husband, were forlorn and left uncared. They or their wards/caregivers had to run from pillar to post to submit their family pension applications and get their family pension. Though they were free to seek the help of CBROA, they were not adequately informed of the role played by the CBROA in helping the retired bank officers' community. Many of them were not even aware of Family Pension, procedure, etc. Approaching the branches, was found unhelpful. Either they were asked to come again or approach the Pension Fund.

Hence, the CBROA has rightly resolved to bring the family pensioners and spouse our members under their umbrella in order to give them feedback about organisational affairs, communicate with them in submitting Life Certificates, arranging Life Certificate camps at centres where adequate of number of pensioners are concentrated, and such other services. CBROA is also thinking of evolving a welfare scheme for the associate Members in course of time depending upon the **corpus developed** with the enrolment

fee of Rs.1,000 which is payable one time only at the time of admission. The idea behind organising the family pensioner and potential family pensioners is to inculcate a spirit of cooperation, one for all and all for one! The corpus built would be used for the welfare of the family pensioners.

The initiative of CBORA has received very good initial response. Our Office has received more than 300 applications during the month of May, 2023 itself. This shows the confidence of our members with CBROA. While thanking the membership for their positive response, we assure that we spare no efforts to live up to their expectations!

We request you to keep up the tempo and enroll your spouse as an Associate Member. Also, we request you to spread the message among all family pensioners and bring them to our fold.

Our Central Office has already sent

CBROA IS WITH THE RETIREE DURING HIS LIFE TIME AND THEREAFTER TOO! INCREASE IN LIFE MEMBERSHIP FEE

You are all kindly aware that effective from 1st June, 2023, new enrolments to CBROA as Life Member will be on payment of one time fee of Rs.6,000 as against the existing Rs.4,500. It was understood that the Life Time Membership Fee was last revised way back during the year 2010. The revision has been made after lapse of nearly 13 years. During the intervening period the costs have increased.

CBROA is not a business unit that works for profit. CBROA is a welfare institution that channels the cooperative spirit of its members for the benefit of the retired officers community in Canara Bank. The resources for the activities, meetings, conferences and welfare measures are to be met from the subscriptions and liberal donations from its members only.

Further, there were no inflow of annual subscriptions from nearly 600 members. The follow up and connected accounting work put lot of burden on the Central Office which manages its affairs only through the voluntary service of its activists, there are no paid staff at the Central Office. It was imminent to do away with the Ordinary Membership and increase the Life Time Membership Fee. The Association shall depend on the interest income and liberal donations for its day to day functioning and welfare activities.

Members may kindly remember that as against their LIFE TIME SUBSCRIPTION of Rs.6,000, they are entitled to reimbursement of Hospitalisation Expenses upto Rs.25,000 and Rs.7,500 Death Relief is given. This means nearly 4 life time members of Life Time Subscription has to be spent to reimburse every claim of Rs.25,000 on account of Hospitalisation expenses. I need not dwell more on this, since we are all veteran bankers and know the economics of funding the welfare activities. Hence, there is need to enroll as many members to CBROA to keep up the benevolent activities of the Association.

Let us all put our efforts to bring all Retirees, their spouse and Family Pensioners from Canara Bank under the banner of CBROA, which is an organisation, not only for the members during their life, but later also.

1.Sri PPJ NAIR

Sri Ghai in his address briefed on developments on burning issues of the retirees like Updation of pension, 100% DA neutralisation for pre retirees 2002, IBA medical Insurance Scheme etc. He in his speech discussed in detailed on topics - "CHANGES ON STAGNA-TION INCREMENTS IN 11TH BPS" and "EXEMPTION LIMIT OF INCOME TAX ON LEAVE ENCASHMENT". He informed the members that earlier the stagnation increments were released after completion of three years and in 11th BPS, it has been provided that the stagnation increments shall be released after completion of two years services wef 01/11/2017 but its monetary benefit on account of such adjustment shall be paid wef 01/11/2020. The members who retired between 01/11/2017 and 31/10/2020 shall get its benefit on his pension wef 01/11/2020. He advised the concerned members to ensure that they have received the benefit on account of such revised and readjusted periodicity of stagnation increments. He informed that if any member has any doubt on it, he may approach to him for clarification.

Giving the reply to the queries of the members on enhancement of exemption limit on leave encashment on superannuation, Sri Ghai requested the members to recall his earlier speeches in earlier meetings as well as his various messages in local group wherein it was advised to them to claim the tax rebate on full amounts of Leave Encashment while filing the returns. In the meeting there were 6 members who informed that they claimed the tax exemption on Leave Encashment and they received the refund. Only in one case, the notice to refund was received from the IT authority But that notice was replied by him with the expert advice/draft of our Regional Sectretary Sri D Goyal (from Jaipur) & his team. That member further informed to the house that two day before, he received the communication from the Income tax for releasing his refund for the subsequent year which was kept on hold. That means income tax has cleared his case. In our region, around 12 members claimed this rebate and so far all got refund thereon. The house appreciated the efforts of our ex office bearer Sri B L Maheshwari who continuously raised the voice against this anomaly in all the CC meetings. 

INSURANCE OMBUDSMAN AWARD

.Shri G Sasidharan Pillai (Mem No 3159) was admitted in Ayurvedic Hospital for treatment of Arthrosis Knee Osteo arthritis and was discharged from the hospital after 13 days. After discharge, he submitted the claim documents for claiming amount of Rs.55,000/- to TPA. But TPA repudiated the claim with the following reasons:-

"4.19 Charges incurred at hospital/nursing home primarily for diagnosis x ray or laboratory examinations or other diagnostic studies not consistent with diagnosis and treatment of positive existence of any ailment, sickness or injury for which confinement is required at a Hospital/Nursing Home unless recommended by the attending doctor. As per the claim documents received, it is observed that there is no active line of treatment during hospitalization".

When the appeal made to the Insurance Company failed, the member preferred an appeal to the Insurance Ombudsman, Kochi, Kerala. Our Deputy General Secretary, Shri Satish Kumar Ghai, aided and assisted Shri G Sasidharan Pillai from Dehradun! His service is exemplary. Please go through the award! Justice will be rendered to those who not only seek it, but fight for it with perseverance!!

COMPLAINT REF: NO: KOC-H-048-2223-1097

Brief Facts of the Case:

Mr.G Sasidharan Pillai P was admitted to Arya Vaidya Sala Kottakkal - Malapuram on07-Jun-2022 and treated for [Auyrvedic] Arthrosis Knee Osteoarthritis, and after treatment discharged from hospital on 20-Jun-2022. After discharge from the hospital insured had submitted claim documents with claim amount of 55030/- . On scrutiny the RI observed that during hospitalization of 14 days, patient was treated with Manhalkizhi, Pizhichil, Upanah with oral medication. In their opinion for said line of treatment Hospitalization was not necessary, same treatment could be possible on OPD basis. The Claim was repudiated under policy clause 4.19 as - Charges incurred at Hospital or Nursing Home primarily for diagnosis x-ray or Laboratory examinations or other diagnostic studies not consistent with or incidental to the diagnosis and treatment of positive existence of presence of any ailment, sickness or injury, for which confinement is required at a Hospital / Nursing Home, unless recommended by the attending doctor. Dr. Sreelatha V by certicate number 07.05.2022 has certified that Mr. Sasidharan Pillai G was under her treatment for his complaint of Sandhigata Vatom (Osteo Arthritis). That he is suffering from this disease since 2008 and undergoing panchakarma treatment as per her advice and instructions. As there is no Inpatient hospital for Kottakkal Arya vaidya Sala in Kollam she referred him to their Head office at Malappuram. Certificate from Arya Vaidya Sala, Kottakal dated 20.06.2022 certifying that Mr.Sasidharan Pillai G was under their treatment for Sandhiugtavatah. Gonathrosis (Arthrosis of knee) from 07.06.2022 to 20.06.2022. Discharge summary submitted indicated Therapy/Procedures done-Manhalkizhi, Pizhichil and Upanaham, Medications seen administered.

Contention of the complainant:

The complainant is covered under IBA Group Mediclaim Policy for Canara Bank Retirees for the period 01.11.2021 to 31.10.2022. The policy holder/patient submitted the subject reimbursement claim on 01.07.2022 related to his hospitalization at Arya Vaidya Sala, Kottakkal from 07.06.2022 to 20.06.2022. TPA repudiated the said claim with the remarks:-"4.19 Charges incurred at hospital/nursing home primarily for diagnosis x-ray or laboratory examination or other diagnostic studies not consistent with diagnosis and treatment of positive existence of any ailment, sickness or injury for which confinement is required at a Hospital/Nursing Home unless recommended by the attending doctor "As per the claim documents received, it is observed that there is no active line of treatment during hospitalisation,hence claim repudiated.On 13.09.2021 he made a complaint but no reply received. As per clause no.3.2 the subject claim is fully admissible. The medical certificates of the hospitals dated 07.06.2022 and 20.06.2022 given by two different doctors as well as the Discharge summary confirm that the patient was diagnosed with ailment Arthrosis of knee". The treating doctor is the best person to decide what kind of procedure is required to diagnose and treat.

Contention of the Respondent:

Patient was admitted to Arya Vaidya Sala Kottakkal - Malapuram on 07-Jun-2022 and treated for [Auyrvedic] Arthrosis Knee Osteoarthritis, and after treatment discharged from hospital on 20-Jun-2022. After discharge from the hospital insured had submitted claim documents with amount of 55030/- . After review of the claim documents, said claim is repudiated as per the Policy Norms. A 73 Yrs. male patient was admitted for complaints of pain in both knees Lt> Rt, both ankle pain, varicose vein, blackish discolouration and itching all over legs. During hospitalization of 14 days, patient was treated with Manhalkizhi, Pizhichil, Upanah with oral medication. For said line of treatment Hospitalization is not necessary, same treatment could be possible on OPD basis. As per claim documents received it is observed that there is no active line of treatment during hospitalization. The Claim is Repudiated under policy clause 4.19 as - Charges incurred at Hospital or Nursing Home primarily for diagnosis x-ray or Laboratory examinations or other diagnostic studies not consistent with or incidental to the diagnosis and treatment of positive existence of presence of any ailment, sickness or injury, for which confinement is required at a Hospital / Nursing Home. unless recommended by the attending doctor.

Observation and conclusions:

The Complainant is the holder of Basic Policy (family floater) no.251100502110000279 issued by the RI effective from 01.11.2021 to 31.10.2022. The claim is for his admission at Arya Vaidya Sala, Kottakal. The policy was valid at the time of the occurrence of the event that has given rise to the claim under discussion here. The RI has rejected the claim for treatment undertaken by the Complainant at Arya Vaidya Sala, Kottakkal, Ayurvedic Hospital and Research Centre invoking CRS Clause: 4.19 and going on to say that there was no active line of treatment during hospitalization; he could have been treated on OPD. I have gone through the said Clause which reads as follows: "Charges incurred at hospital/nursing home primarily for diagnosis, x-ray or laboratory examinations or other diagnostic studies not consistent with diagnosis and treatment of positive existence of any ailment, sickness or injury for which confinement is required at a Hospital/Nursing Home unless recommended by the attending doctor." I do not see how this Clause can be invoked in respect of the claim in question. This Clause seeks to exclude hospitalization purely for diagnostic purposes, where a patient has been admitted to hospital merely to facilitate tests and not for any treatment of an identified disease or ailment. In the claim under discussion, there is no doubt that rather than merely for diagnostics, the admission was for a clearly defined and recorded treatment process. The invoking of this clause is thus completely misplaced. The Complainant has produced certificate from the hospital and Doctor at Arya Vaidya Sala, listing out the treatment undergone and the need for hospitalization. The treatment and process undergone include-Manhalkizhi, Pizhichil, Upanaham, all of which are commonly known to be major procedures done by trained staff under controlled conditions and accompanied by strict norms on rest, diet restrictions etc. Quite obviously these procedures cannot be conducted on an OP basis. They have to be, and in our common knowledge they invariably are, administered only with patients admitted as Inpatients and staying at the hospital for the number of days required according to the procedures involved. The conclusion of the RI (or their TPA) that this needn't have required hospitalization is unacceptable, being based on nothing but conjecture. In view of the above, I have no hesitation whatsoever in concluding that the treatment undergone at Arya Vaidya Sala Ayurveda Hospital and Research Centre by Mr.Sasidharan Pillai G, the Complainant is a bonafide IP treatment that falls within the ambit of cover under the policy and allowing the expenses incurred by the Complainant for the same.

AWARD

COMPLAINT REF: NO: KOC-H-048-2223-1097

In the result, I hereby order as under: The Respondent Insurer shall reopen the file, reprocess the claims and pay the Complainant the amount in full and final settlement of the claim. As prescribed in Rule 17(6) of Insurance Ombudsman Rules, 2017, the Insurer shall comply with the award within 30 days of receipt of the award and intimate compliance of the same to the Ombudsman.


