We have also requested to include Thyroid and HBAIC in the package at concession rate. He readily agreed for the same too!





Sub: Grievance Redressal Meeting with the representatives of retired employees'/
officers' associations proposed to be held on 27.9.2023.

With reference to the subject meeting proposed to be held on 27th Sept. 2023, we submit the following agenda items to be taken up for discussion/redressal.

- Group Medical Insurance Scheme for retirees Subsidising the huge premium paid by the retirees.
- Extending rebate on Lockers hired by Retirees from 25% to 50% which was assured by our beloved MD & CEO.
- Rate of interest on Employees Pension loans Need for reduction, atleast to be on par with the clean rate of interest charged to serving employees/officers.
- Clarification regarding newly introduced stagnation increments in 8th joint note Need for proper interpretation.
- Providing online facility for updating address, mobile number and e-mail ID of retirees in Canarites app.
- Celebrating "Azadi ka Amrit Mahotsav" Payment of Ex-gratia to all the Pensioners on the lines of State Bank of India.
- Staff Welfare Measures Reimbursement of medical expenses Extending the benefit to those retired on CRS.

- Staff welfare measures Extending the scheme of payment of funeral expenses on the sad demise of a retiree.
- Holiday home facility for retirees Request for removing certain restrictions & suggestion for the optimum use of holiday homes.
 - Remove the restriction of booking a particular holiday home only once in a calendar year and make it atleast once in a quarter.
 - Increasing the number of rooms to minimum 10 in all the places especially where there is great demand for holiday homes and reserving minimum 40% of the rooms for retirees.
 - Stipulating a caution deposit of Rs.1000/- and forfeiting the same in the event of non-cancellation of the rooms before 7 days of checking.
 - Allotment of thee cancelled rooms or vacant rooms on account of non-checking to the needy employees by the concerned RO/CO.
 - Linking holiday home bookings on LFC to the sanction of LFC proceedings in HRMS to avoid cancelling the same and converting it into normal booking at a later date.
- Request for affixing the combined photo of the pensioner and the dependent handicapped children in the PPO.
- Simplification of Family Pension sanctioning procedure Signature can be attested by the Branch Manager instead of 2 persons separately and enabling online submission of the application.
- Request for charging ROI on Education loan (both inland and foreign) to the wards of retired employees at par with that of employees.
- 13. Proper treatment of retirees, who are also senior citizens by the branch staff Need for guiding the branch officials by RO/CO/HO in their meetings/interface and issuing suitable advisory to the branches.
- 14. Attending to retiree's complaints on priority basis especially regarding resolving short payment of interest on deposits, excess charging of higher interest on advances (mainly due to non-adhering to applicable norms to ex-employees), not refunding the wrongly collected service charges, folio charges, excess locker rent etc.
- VSL and OD against Staff Term Deposit Branches are unable to extend slab rate of interest to retirees on account of lack of provision in CBS. Need for introducing Multilevel interest product code for O.D (Deposits) for Employees/Ex-Employees
- 16. Providing immediate support in CBS for facilitating/extending various benefits to exemployees like slab rate of interest on VSL/OD, waiving of service charges, folio charges, rebate on locker rent etc. which would go a long way in resolving many complaints by retirees.

- Calling for explanation / initiation of departmental action after expiry of the period of limitation
 of 4 years set by the Bank Need for reiteration of the guidelines to all the Circles/ROs.
- Defending the charge sheeted retired officer by the representatives of retired officers' association/s - Need for restoring the abruptly withdrawn facility.
- 19. IBA's advisory on calculation of commutation factor for those retiring on the afternoon of the previous month whose 60th birthday falls on the 1st of the next month Need for seeking legal opinion and interpreting the true spirit of the regulation 41 (6) of Pension Regulations, 1995.
- 20. Continuation of secured loan liabilities post-retirement Need to have a uniform format/procedure across all the circles. Further, message/letter may be sent to the officers 30 days prior to their superannuation seeking their option to continue their loan liabilities (Housing Loan and Vehicle loan). Alternatively, provision should be made in HRMS for submitting the request along with other pension papers.
- 21. Review of the pending issues of the previous grievance's redressal meeting.

AIBPARC NEWS

AIBPARC MEETING HELD ON 27th OF SEPTEMBER 2023 AT BENGALURU Dear All,

There was a meeting of the members of the affiliates of AIBPARC at the Party Hall, Krishna Prakash Apartments, AICOBOO Nagar, BTM Layout, Bengaluru on 27th Sep. 2023 at 03.30 pm.

The meeting was presided over by Sri M R Gopinatha Rao, President, Karnataka State unit of AIBPARC and Sri G D Nadaf, Chief Advisor and Sri K V Acharya, National President of AIBPARC were present in the meeting. Sri A N Krishnam Murthy, State Secretary conducted the proceedings & explained the purpose & immediate need to call for this meeting.

Sri Gopinatha Rao, while welcoming all briefly mentioned about the steeply escalated health insurance premium.

Sri Nadaf in his address narrated how the insurance scheme for State Bank of India employees started and it's functioning there at present. He also explained how the insurance scheme for other banks was mooted by the Govt and how it was implemented.

As advised by Sri Nadaf, opinions by members were called. The members' opined as follows:

- 1. Being stake holders for the scheme, retirees organizations should be called for discussions on the scheme.
- 2. The organization may explore options of alternative insurance schemes.
- 3. We may form an umbrella body of all Retirees' organizations.
- 4. The confederation should demand for clubbing of policies of working persons and retirees so that the average claim ratio will be reduced and the premium will come down.
- 5. AIBPARC GC Meeting is scheduled to be held on 29th & 30th of Oct. 23 at Chennai & by that time, the entire process of renewal of IBA Health Insurance Policy would have been over. Hence, a Virtual Meeting of the GC be convened at the earliest to chalk any steps regarding Retirees Insurance Scheme.

Sri K V Acharya in his address dealt all matters in detail. He said that with the constant persuasion by the Confederation, 100% DA neutralization to pre- Nov 2002 retirees could be achieved and minutes signed. On the clearance by the Govt, he said he is optimistic that it will be cleared soon.

On the matter of updation of pension, he said the case is coming up in the SC on 10th October, 2023 and said there are hopes of achieving it. He said that there were many hurdles within UFBU and from IBA and now it has come to a decisive stage.

On the hiking of insurance premium, he said with the advanced age of members the claims have naturally gone up forcing hike in premium. Now since all banks are in good profit, individual Bank managements may be impressed upon subsidizing the premium to maximum possible extent. As a step towards this, meeting the MD & CEO of Canara Bank was planned.

On exploring alternate insurance plans by other companies, he said there are many clauses of lock-in periods for certain periods and for certain ailments. He said the insurance cos, under tie ups may not be certain to continue as have happened in many instances. Since the IBA policy has coverage of pre-existing diseases, coverage from day one and lifelong renewal of policy, it is best suited for retirees especially super senior citizens who otherwise do not get health ins coverage.

On the matter of some retiree organization approaching CLC in the matter of health insurance, he said the CLC has merely directed the IBA to discuss the issue with the concerned retiree organization.

He said there are indications that the Govt may consider waiving or reducing GST on Retirees' ins premium which may be announced shortly.

On clubbing of policies of working personnel and the retirees, he said even if the IBA agrees, the ins cos are not willing to club them.

Sri A N Krishna Murthy said he shall arrange meeting with the MD & CEO of Canara Bank and subsequent meetings with other Bank CEOs may be taken up for subsidisation of insurance premium.

The meeting concluded with vote of thanks.

Otherwise in any unfortunate event they will not get Preferential ROI applicable to ex employees and there will be difficult for them to receive family pension in package. This is discussed once again basing on the advice given to us 3 years back.
- 2. All members and those above 70 in particular are finding it difficult to renew IBA policy. They can not be without insurance and cannot afford taking a new policy. All members felt that the premium is unaffordable and expressed dissatisfaction about premium hike and requested CBROA to vigorously try for subsidy from Bank/ to alternative to IBA policy. It is suggested health insurance policy by management on the lines of SBI to be evolved.



3. We also discussed about new policies of various companies. In view of hidden threats in Group policies like IBA, BAGIC, TAGIC, CanMediclaim, Star Group policy of BOB and etc, it is opined that individual policies are better than Group policies. Since in individual policies there will be direct dealing between the insurer and insured and can have choice of terms. We discussed about HDFC Ergo, Niva Bupa, Care, Iffco Tokio and Reliance. Some companies are giving policy even

for above 65, loading extra premium. Some companies 'lock in' ranging from 6m to 2 years depending on disease, yearly health checks are permitted upto 10% of Sum Insured.

4. We have also touched upon 100% DA neutralisation and updation where it stands..Members are anxiously waiting for outcome of 6th/10th October 2023...


A LESSON FROM A DUST BIN
