# SBI GEN SUPER TOP UP POLICY OFFERED BY K M DASTUR, REINSURANCE BROKER

It has been a hectic 15 days for us at Central office, Bengaluru in successfully completing the exercise of receiving payment under SBI General super top policy offered by Dastur and reconciling the payment received with that of the details submitted in online form. 1389 retirees including many non-members have opted for the policy. We have completely explained the pros and cons of subscribing to the super top policy vide our circular 6/2023 and

7/2023 to enable our members to take a prudent, judicious decision to subscribe to the policy. We furnish below the list of 1389 retirees (sorted staff number wise) who opted for SBI General Super Top policy. All the details submitted by the optees in the online form are available in the list. Please go through the same and if any, correction is to be made, send a mail

Friends, CBROA opted for subscribing to SBI Gen Super Top up policy offered by KM Dastur, reinsurance brokers only to help the interested members to subscribe for the same as

the policy is issued in the name of retiree's associations (i.e. CBROA). Though we have successfully completed the exercise of collecting the premium within a record 5 days and remitted the same to SBI General account on 31.10.2023. the reconciliation of the premium amount with that of the online form has been a humongous task undertaken by us at central office. Despite all odds, various difficulties we could complete the reconciliation work on 6.11.2023. In this connection, I profusely thank Sri. R N Pandit, Sri. D A Suresh and Smt. Thriveni Barkur in helping us in reconciliation work as well contacting over 100 members to help them in submitting the online form besides seeking information regarding the payment. Our team worked very hard for the last 15 days in achieving the task. Anyway, at the end of the day, it was satisfying that we could help some of our members/ retirees in their hour of need.

#### 100% DA Neutralisation for pre-November 2002 retirees

We are happy to note that the long pending demand of CBROA has at last been achieved with the involvement of all the stake holders, especially the AIBPARC, our apex organisation and UFBU. We thank the IBA and the Govt for considering this two-decade old demand of bank retirees. In our Bank, over 15000 retirees and 8000 family pensioners have been benefitted. It is

a befitting Deepavali gift to all our senior/super senior members. The average increase in the pension would be in the range of Rs. 6000/- to 20000/- for officer retirees who retired prior to November 2002. In percentage terms the average increase would be in the range of 20% to 50% depending upon the scale.

#### **APPEAL FOR DONATION**

Dear friends, I was little hesitant to give a call seeking donation from our senior members whose pension was increased due to the implementation of 100% DA neutralisation. However, I felt humbled by the generous donation made by many members. The generous donation shows the love and affection of our dear members towards CBROA and their confidence in the leadership. #### AIBPARC GOVERNING COUNCIL MEETING

We have pleasure to convey that large number of GC members from different parts of the country attended the above meeting for consecutive two days and made a thorough review of the current situation prevailing in the Industry specially in respect of Bank Pensioners and Retirees.

The principal highlights of the meeting are informed hereunder:

Com. K.V. Acharya, President, in his initial address applauded the organization for achieving the demand of 100% DA neutralization for the senior most segment of membership. He traced all the major developments in the retiree's movement of the country since holding of the Nagpur conference till today and narrated in brief the major organizational programmes and activities for achieving core

demands which had been identified at the first General Body conference held in Delhi. He thanked IBA for acceding to the request of AIBPARC for addressing the letter in respect of implementation of 100% DA neutralization issue to all the member Banks which had been parties to the 1993 Pension Settlement. He expressed stubborn hope that the remaining issues including Pension Updation would also be honorably resolved. He also apprised the members present about the latest position of the pension updation case pending before the Hon'ble Supreme Court.

The summarized position of different issues is placed hereunder:

\*The House expressed joy and satisfaction at the successful resolve of the issue of 100% DA neutralization.



\* The organization will now employ its fullest endeavour for achieving pension updation for all.



\* The House deliberated for a long time

on the issue of Medical Insurance which has brought endless misery in the life of the Bank Retirees.

\*The House felt that the IBA scheme was a product of long struggle by the organization and the organization should try its level best to retain the scheme and work relentlessly for its improvement.

\*The organization for a long time has been escalating the issue of allowing second option to pension for all the left outs including the Resignees.

\*The meeting expressed serious displeasure over IBA's not allowing formal consultative status to different apex level Retiree organizations including AIBPARC.

\*The House noted with serious concern that one major constituent of UFBU has been floating different suggestions / opinions at different points of time which ultimately aim at distortion of the provisions of BEPR (1995) and also duly amended in 2003 in regard to Pension Updation.


many senior members submitted options ONLINE with the assistance of our volunteers. More than 56 people attended this session.
