PENSION UPDATIONV/s EX GRATIA PAYMENT - ANALYSIS OF THE VARIOUS VIEW POINTS...

I am furnishing/analysing the various/differing viewpoints of various stake holders for the benefit of our members.

When all the retirees' organisations are harping on pension updation, suddenly, UFBU entered into an agreement with IBA to introduce monthly ex-gratia payment to all the retirees retired prior to 31.10.2022, the terms and conditions would be decided later. All these years, the retirees' organisations are demanding pension updation on the lines of RBI and they have taken up the matter with various authorities like IBA, DFS, Bank managements etc. and vigorously following up for the same!

However, as if bolt from the blue, UFBU, as if to circumvent the efforts of these retirees' organisations and with design and motive, have some introduced the concept of ex-gratia payment to retirees in lieu of pension updation. Why? It appears it is a case of one upmanship! Or is it a design to negate the adverse decision of the Supreme Court in the M C Singla's case which is scheduled to come for hearing on 1st March 2024? The undersigned warned the AIBPARC leaders 15 days prior to the signing of the agreement with IBA by UFBU about introduction of "ex-gratia" and requested them to act proactively to take up the matter with DFS. But unfortunately, the prediction came true! Now, the issue of pension updation for Bank retirees has become so much complicated that the different stake holders, like DFS.UFBU, IBA, AIBPARC and other retirees' organisations are playing different tunes at different times and it appears that everyone is trying to outsmart the other on the issue of pension updation for bank retirees. It is quite clear that UFBU, IBA and DFS are not having any sympathy towards the plight of aged pensioners drawing meager pension for two decades. It is quite clear that Government is not ready to increase burden of pension payment anymore. That is why the issue of pension updation is pending for more than two decades, especially, eve n after so called advice given by FM in November 2020, IBA is not resolving it. UFBU is aware of the facts and hence not ready to resolve the issue of pension updation.

IBA and other stake holders always tried to deny legitimate entitlement of Pensioners on one or other pretext as "No mandate from banks", Pending Court cases: matter sub-judice, No funds in Pension Funds, huge costs, No provision of pension updation in Pension Regulation 1995. There have been no restrictions on IBA, UFBU or DFS to release ad hoc payment pending final disposal of Court cases. Courts never object on any ad hoc payments but encourage such gestures. However, IBA and UFBU suddenly entered into an agreement introducing ex-gratia payment to Bank pensioners in lieu of updation of pension!

After the introduction of ex-gratia payment, all our retirees' organisations felt betrayed and demanding updation of pension on RBI lines and sending various representations/letters IBA/DFS demanding pension updation in terms of regulation 35(1) provided in BEPR 1995. Now, coming introduction of ex-gratia payment, UFBU Convener has gone on public saying that the suggestion of ex-gratia interim relief arrangement pending finalisation of pension updation through Court. If it is so, it must have been stated clearly in MOU/agreement dated 7th December, 2023.

UFBU says that Pension agreement was part of BPS & that any amendment will be decided with mutual consent but do nothing to amend the regulations in favor of Retirees. It appears IBA/UFBU are hands in gloves with each other for twisting the clause 35(1) to suit their interpretation even after its inclusion in 2003.

If AIBEA and UFBU jointly and collectively taken a decision to accept Ex Gratia offered by IBA as an interim arrangement, the responsibility lies with the authorities to give reasons. Then why Ex-gratia is permitted instead of Pension Updation under amended regulation35.1 inserted 20 years back in the year 2003.IBA owes responsibility to explain the circumstances under which Regulation 35.1 was amended in 2003.

Anyhow, the natter is in court since a long time, and may be court verdict will be delivered in the Month of March 24, unless vested interests managed to get it adjourned further. In fact court case had to be adjourned for more than a year, just because, despite repeated orders by SC, IBA did not submit in SC the report of their committee. When the matter has reached final stage, it is really puzzling why Unions, especially AIBEA is eager to offer Ex gratia instead of Pension Updation on RBI line?

Such hurriedly taken decision about an issue which was never a part of BPS for past 20 years, gives clear indication and proof that IBA and AIBEA are having different motives than just to give financial benefits to pensioners. If the decision was taken with intentions, IBA and AIBEA could have released Ex-gratia in 2015 itself when they signed record note stating that pensioners have no contractual relationship with Banks. Once you have taken such stand, it was but natural that pensioners can get any monetary benefit as a mercy and not as a right. Why IBA and AIBEA did not show such mercy towards 5 lakh bank pensioners for more than 8 years after signing record note in May 2015. What were the compelling reasons to declare Ex Gratia before signing 12BPS. What were legal compulsions to club Ex gratia with BPS, that too when Pension Regulations have no provision for Ex gratia.

Retirees' organizations demand for Pension updation on RBI lines is as per agreement/understanding as laid down in sub-committee report of 1994 also. It is also a misfortune that clause 35(1) appendix I, as amended in 2003 are not properly understood. Why it continuing if it was meant for the retirees retired during the period of 01.01.1986 31.10.1987 to Emphatically it remained in regulations as Pension was to be updated with every wage revision. No doubt, Pension Scheme was introduced in banks only after agreement was signed between Management and Unions. That was necessary, as pe rules prevailing at that time. Employers, including banks were compelled to pay certain amount as PF contribution. This was statutory responsibility. Hence, you cannot by pass such legal provision unless both the parties agree to replace PF system with any other system including assured monthly pension.

As the pension scheme was replacing then statutory provision of PF pplicable to all employers, pension was made optional. That's why only those who opted for pension were covered under Pension scheme. There were legal issues to make pension mandatory. Although, scheme was introduced as a sequel to agreement between Banks and Unions, it was not introduced in banks under agreement.

The pension scheme was introduced through a bill passed in the Parliament. Hence pension scheme introduced in banks is now under statutory provisions and terms and conditions of the scheme are governed by the act passed in the Parliament.

Naturally, any changes or amendments in the Pension Scheme can be brought only after amendments are passed in Parliament. Thus, Pension Scheme as stands today is the property of Government backed by a bill passed in parliament. Under statutory provisions; government has full rights to make any amendments in the bill, provided it does not take away any rights available to retirees At the pensioners. same time government has got every right to additional benefits extend improvement in the scheme if amendment is passed in the Parliament.

As pension scheme is product of the bill passed in Parliament, courts have jurisdiction to ensure that any beneficiary is not denied rights or benefits available under the scheme. In contrast other service conditions are governed by BPS, agreement executed between Banks and Unions. Hence dispute about BPS terms can be referred to labour Courts, and governed by ID Act.

Whereas dispute or grievance in pension matters are resolved directly

through court proceedings, the court will look into dispute within the frame work of actual provisions incorporated in the bill passed by the Parliament. It's immaterial what was discussed in preliminary stages and what was the intention of the parties, especially employees. The issue of pension updation has become complex as whatever we pensioners claim as rights are not clearly included in the bill. If the bill lacks clarity or has omitted provisions, unions certain expected to raise the issues with IBA and Government to ensure that proper changes are made in Pension Regulations to give benefits as desired by the beneficiaries.

Regulation 56 is just a guiding principle and not a legal provision. Equality and uniformity cannot be claimed as a matter of right, unless suitable changes are made in the scheme in line with provisions incorporated in RBI Pension Scheme.

Although IBA and UFBU can recommend certain changes in the scheme, the final decision lies with DFS. Unless DFS bring amendment and arrange to issue notification in Gazette the amendments cannot be implemented by banks or IBA. They need clearance from DFS, including date of effect of such changes contemplated through amendment. That's why all changes made in recent are introduced only past notification was issued by govt. Family Pension Revision was affected only

after govt issued notification in the month of August 21.

Our fingers are crossed, Hope we will be able to prove our points effectively and legally in the Supreme Court. Emotions cannot give you success in court battles.

Ultimately, we believe that whether the court judgement will be in our favour or not, we the public sector bank retirees have inalienable right to demand for reasonable pension updation, because, pension of central govt/state govt/RBI/NABARD employees are being updated periodically. All these retirees of Central/State Govt are not only getting pension updation, but also additional pension after attaining an age of 80 plus years. Now, the Govt. is thinking

of extending additional pension to all retirees who have attained the age of 65, 70 and 75 years too. Even State Bank of retirees has got their pension increased from 40% to 50% despite the same being a third benefit. What an irony? Hence, instead of solely depending upon the court judgement, all our serving and retired trade unions should bring pressure on the Central Govt to get our rightful, reasonable pension updation. Ultimately, it is a political call to be taken by the Govt.

- 3. The 2 years cooling period for new Life Members to be eligible to avail medical relief is not good. How can we be sure that the Member will not fall sick during this period? Even the IBA insurance policy is not putting this condition.
- 4. The minimum Hospitalisation bill amount cap of ₹ 3.00 lakh may be reduced to ₹ 1.00 lakh for those who do not have any mediclaim cover.

- 5. The minimum claim amount of ₹ 10000/- may be done away with.
- 6. The members unequivocally pledged to strengthen the beloved CBROA by giving full support to clinch benefits for the members.



The Meeting Chairman Mr R. C. Gupta, a veteran and very seasoned member summarised the proceedings and deliberations giving full consent to the feelings of the members.

The RS, Mr. Kanchhi Lal, thanked the members for their attending the meeting despite the severe cold.


