

FEBRUARY 2024 FROM THE DESK OF GENERAL SECRETARY



28th Foundation Day of CBROA....

Today, 6th February 2024 is the 28th Foundation Day of our beloved CBROA. I feel honoured and privileged to be the Secretary of General this great organisation at this juncture. I would like to reminisce the glorious path tread by CBROA during the last 28 years.... CBROA came into being on 6.02.1996after introduction of Pension Scheme in Banks to champion the cause of retired employees in Canara Bank. While the trade union of serving employees in Canara Bank was focused mainly for the improvement of service conditions, the retired employees felt the need for focused attention of their issues. In the wake of implementation of Pension Regulations on 29.09.1995 there were many issues pertaining to pensioners which could be redressed through an

organisation. Hence, the need to organise the retires of our Bank was felt. The erstwhile leaders of Canara Bank Officers' Association (CBOA) having felt the pulse of retired employees decided to organise the retired employees under the aegis of CBOA and founded Canara Bank Retired Officers'Association with the aim and object of protecting the interest of the retired bank employees in Canara Bank. Sri.B Sudhakar Shetty then General Secretary of CBOA played a key role in forming and giving the Association a concrete shape.

All India Bank Pensioners' and Retirees Confederation (AIBPARC) was formed on 12.03.2012 in its foundation Conference held at Nagpur. Canara Bank Retired Officers' Association is now one of the proud contingents of AIBPARC which has grown in strength and stature in a short span of time. Now CBROA is the largest Retired Officers' trade union in Canara Bank. Canara Bank Retired Officers' Association with the vanguard support of Canara Bank Officers' Association has been able to prevail upon our Canara Bank to extend the following benefits. a) Issue of Identity Cards to Retired Officers b) Reimbursement of Medical Expenses c) Waiver of Processing Charges d) Issue of Identity Cards to SVRS optees e) Extension of additional 1% interest on Retirees Deposits f) Extension of Holiday Home facility g) Permission to open Joint Account with spouse for Pension Account h) Loan to Pensioners i) Engaging retired officers as Inspecting Officers(Field), Inquiring Authority, Faculty Members, Recovery Agents, Direct Selling Agents (DSA), etc. j) Reimbursement of Medical Expenses to family pensioners k) Payment of additional ex-gratia to pensioners and family pensioners to pre 01.01.1986 retirees. I) Creation of structured bilateral forum for redressal of Pensioners' Grievances at periodical intervals. Canara Bank is the first Bank in the entire Banking Industry to create a structured forum for redressal of pensioners' grievances by holding Meetings with the representatives of CBROA at regular intervals. The Top Office bearers of CBROA will be calling on the Executives at Head Office regularly to sort out some of the grievances of the pensioners/retirees. Ever since CBROA has been formed, the CBROA has been involving itself in ameliorating the grievances of retired employees, be it defending the beleaguered retired officers in disciplinary actions, helping them in drafting suitable replies to the memos issued, extending financial assistance in the form of death relief, reimbursement of hospitalisation expenses,

welfare measures, settlement of grievances regarding IBA Medical Insurance in coordination with Bank, TPA and Insurance Company.

Apart from the above benefits/achievements which are secured Bank, from our CBROA has been spearheading the cause of retirees by taking up the major issues like, Improvement in Family Pension, 100% DA neutralisation of pre-Nov 2002 retirees, Pension option to resignees, pension updation and affordable group medical scheme for retirees. Out of the above issues, 3 issues viz., Improvement in family pension, 100% DA neutralisation, pension option to resignees have been resolved. CBROA is still fighting for decent pension updation and affordable medical insurance scheme through our apex organisation AIBPARC.

Friends, as on today the cumulative membership of CBROA is 14374, the active membership is at 11955. We have a huge challenge in the coming days to increase our membership. You are aware that the total retired officers in Canara Bank is around 32000 out of which around 12000 belong to e-Syndicate Bank, where majority of them are part of another retirees organisation. Though, we are enrolling e-syndicate officers who have retired after amalgamation to our fold, still many retired officers both from Canara Bank as well as Esyndicate are non-members. Hence, we need to focus on these retirees and bring them into our fold. Recently, CBROA has facilitated our members to opt for SBI Super Top policy floated by K M Dastur Company. Many non-members have utilised our facility and used our link to subscribe for the super top up policy. I call upon all these non-members to become members of CBROA in order to have uninterrupted service from us.

You are all aware that CBROA has passed a resolution in the General Body meeting held at Mysuru on 10th and 11th April 2023 to bring all the family pensioners as well as the spouses of our members to the fold of CBROA by enrolling them as Associate Members. The idea behind organising the family pensioner and potential family pensioners is to inculcate a spirit of cooperation, one for all and all for one! While we are extending assistance to the spouse of the deceased, in most of the cases, women, we noticed that after the demise of their husband, were forlorn and left uncared. They had to run from pillar to post to submit their family pension applications and get their family pension. Though they were free to seek the help of CBROA, they were not adequately informed of the role played by the CBROA in helping the retired bank officers' community. Many of them were not even aware of Family Pension, procedure, etc. Approaching the branches, was found unhelpful. Either they were asked to come again or approach the Pension Fund.

Hence, the CBROA has rightly resolved to bring the family pensioners and spouse of our members under their umbrella in order to give them feedback about organisational affairs, communicate with them in submitting Life Certificates, arranging Life Certificate camps at centres where adequate of number of pensioners are concentrated, and such other services.

During the last 9 months, we could enroll about 2600 associate members and still we have a very long way to go. We request you to join hands with CBROA in this noble endeavour and enroll your spouse as an Associate Member. (If not already done). Also, we request you to spread the message among all **family pensioners** and bring them to our fold.

During the last 10 months, we could secure couple of benefits from our Bank, like increase in medical reimbursement scheme under staff welfare measures and also enhancement in concession on locker rent. We are taking couple of other issues like improvement in group medical insurance scheme, reduction of interest on pension loans with the Bank. We hope to resolve these issues with the help of our parent organisation CBOA. With warm Greetings,

SUB: ENHANCEMENT OF LOCKER RENT CONCESSION TO STAFF/EX-STAFF MEMBERS OF THE BANK

SYNOPSIS

Enhancement of concession on locker rentals to the Staff/ Ex Staff members of the Bank from existing concession rate of 25% to 50% on <u>Small /Medium</u> Locker types

Locker Business is an area of Non-Interest Income. Recovery of Locker Rent on time and letting out Vacant Lockers for income generation are vital in Locker Management. Branches and RO/Cos are requested to gear up action for letting out Vacant Lockers to achieve the desired results for the Bank. There are many vacant lockers available in most of the Branches and Bank as a whole vacancy is hovering around 15% out of which 85% falls under Small Lockers. By letting these vacant lockers Branches can earn/increase yearly non-interest income.

We are pleased to inform that Bank has enhanced the Concession on locker rentals for **Small/Medium** type lockers to the Staff and Ex Staff members from the existing rate of 25% to 50% on the prevalent locker rentals.

All the Staff members are requested to utilize and motivate the Ex-staff to avail Locker facility from the Bank.

Humanity is the need for ever, If we are humane we are equal then.




