Dear Friends,

AIBAPARC GENERAL COUNCIL MEETING HELD AT NEW DELHI

CBROA representatives including myself attended the AIBAPARC General Council meeting held at New Delhi on 21.2.2024 to 22.2.2024. It was an opportunity for us to present our views on various issues affecting our members in the GC meeting. On behalf of CBROA, I had presented our views, especially on the issue of pension updation and affordable group medical insurance scheme. I had also touched upon these topics in detail in the members meeting held on 20.2.2024 at New Delhi. The excerpts of my speech are reproduced here for the benefit of all our members. The long pending pension updation issue has taken a curious turn since UFBU has entered into an understanding with IBA to introduce ex-gratia to pensioners in the ensuing 12thBipartitesettlement pending pension updation. On the one hand, our Apex body is fighting for pension updation basing on the Regulation 35(1) as provided in BEPR 1995 and also involved in legal battle. The famous M C Singla case is scheduled to come up somewhere in the third week of March 2024. Hopefully, we wish and pray that the Supreme Court would uphold the validity of regulation 35 (1). On the other hand, the other retiree organisations especially the AIBRF is toeing the line of IBA and the Govt who are strangely sticking to the view that there is no provision in Bank employees

Pension Regulations for pension updation! Our contention is that whether pension regulations provides for pension updation or not, it is inalienable right of every bank pensioner to seek for pension updation. When every Central Govt, State Govt, PSU, RBI, NABARD employees are enjoying periodical pension updation, why not Bank employees? Even in RBI there was no provision for pension updation, then how they got it?. Hence, it is for the Central Govt to do justice for the bank retirees by updating their pension. Even in State Bank of India, where they are enjoying pension as third benefit, they have reached an understanding to enhance their pension from 40% to 50%. That apart, my worry is if the pension is finally updated, how it is going to be implemented uniformly across all sections of the bank retirees who retired in different BPS periods. As we all know that, in Banking industry, "special allowance" component was introduced in 10th and 11th BPS which has drastically affected the terminal benefits especially the pension. On account of this, the basic pension of those retired on or after 1.11.2012 was increased by a meagre 1 to 1.25%. Hence, the difference in pension of an officer who retired in 9th BPS period to those who retired in 10th and 11th BPS period is hardly 3.5 to 5%. Hence, in case of pension updation, on the lines of RBI, there cannot be any meaningful updation for retirees belonging to pre- November 2012, unless the special allowance component of 10th and 11th BPS retirees are reckoned for pension. Today, nearly 60% of the retirees are belonging to 10th and 11th BPS period and hence in order to have a meaningful pension updation across all sections of the retirees, the above issue of special allowance is to be resolved first. Otherwise, there will be unrest, division among the retirees.

Coming to affordable medical insurance for retirees, I believe, it is more important and urgent to resolve this issue since it is affecting all the retirees irrespective of their date of retirement. The ten-fold increase in the group insurance premium over the last 8 years from Rs.7500/- to around 77000/- for a basic policy of Rs.4 lakhs has dealt a huge blow on all the retirees both financially and psychologically. The hapless and helpless bank retirees are pushed to fend for themselves. It is a cruel joke heaped on the retirees by IBA, UFBU and DFS. We need to urgently resolve this issue more than pension updation. There is an urgent need to evolve an affordable health care policy for retirees by combining the policy of serving as well as retired employees and waving GST for the senior citizen policies. Further, Bank management should subsidise the health policies of retirees substantially on the lines of SBI, LIC and other Public sector general insurance companies.

I request our apex body leadership to consider our view points while resolving the above two issues.

REGIONAL ROUNDUP

ALIGARH



So sad, we lost yet another banking legend in Mr. Ashwani Sharma, DGS CBROA.

The devastating news of his unexpectedly shuffling his mortal coil left us nearly petrified for long. It could be like the saddest start to the day for anyone. We never imagined, even in the haziest of our dreams, that our morning greetings would meet with such a shattering reciprocation. For us, even more incogitable was the very thought of my writing this necrology in deference to his noble soul, through the forcing of circumstances. His departure to the better world may be a preordained gain for God but for us, it's a priceless loss. He was not keeping well for quite some time due to some respiratory issues, that nesceciated an Intensive Care. He was hospitalised on 07th of November, 2023 and remained there till the day before he breathed his last on February 12th, just three days after his 69th birthday. Earlier, during September, 2022 at the Bhubaneshwar CC meeting also, he had developed the impaired respiration problem and Team Bhubaneshwar, under the stewardship of Late Gopal Patnaik da, had selflessly extended every possible help, right from hospitalisation to the general care. Born on Feb 09, 1956, Mr. Ashwani Sharma, epitomised all traits of a great leader and a human being. Deep down his marrow, he bore an outgoing, affable and genial disposition, punctuated by acme of suave sophistication. He firmly believed in building bridges and would easily befriend even unknown faces. Ashwani ji was a very active member of AIBEA right since his early days in the Bank and donned many caps, tugged with myriad prismatic feathers. He rose to the rank of DGS during the biennial Conference at Mysore in April, 2023, after traversing a long journey, conspicuously marked by his holding several critical positions i.e. VP (AIBEA Delhi State) and Regional Secretary (CBOA, Delhi Circle). He always wore his heart on his sleeve and was caring to the core. Though no longer around us, but he will eternally remain in our hearts.

I am sure God must Himself had ambled down to the pearly gate of heavens to usher his pious soul to His empyrean kingdom and would have crafted a dedicated niche just about His Holy feet to ensconce it for the eternal bliss.

We pray for his serene soul to subtly meld with its Supreme version.

At the same time We pray that the wheels of these hard times roll faster than the winks to even these edgy movements and help the bereaved gather and come out of this sudden sorrow.

It is rightly said that great leaders are motivated not by power but by compassion and an indefatigable Mr. Sharma was a true example of it.
