### JULY 2024 FROM THE DESK OF GENERAL SECRETARY



Dear Friends.

- 1. PENSION OPTION TO RESIGNEES
  You are all aware that one of the long
  pending demands of the retirees that the
  resignees have to be given an option for
  pension has been achieved and now our
  Bank has come out with a circular
  regarding the same. The salient features
  of the same are as under:
- Employees and Officers who were in service of the Bank on or after 01.01.1986 and had joined the Bank before 01.04.2010 and who have resigned from the service of the bank on or before 26.04.2010 and who were otherwise eligible (those who have completed 20 years of

qualifying service) to join the pension scheme while in service. Who agree to refund to the Bank the entire Bank's contribution to Provident Fund (along with accumulated interest thereon) received by them at the time of their resignation or later from the Bank

- Subject to giving undertaking as per anx-1(withdrawal of court cases, if any)
- No commutation
  - Last date for applying 9th September 2024

At least one of the below mentioned documents has to be mandatorily attached with the application and other

Relieving Letter / Account statement showing settlement of PF contribution / At least one pay slip not more than 10 months old from the date of resignation / Staff ID Card Copy

I request all the eligible officers to avail this golden opportunity. We are glad to give/extend any clarification/assistance regarding the option.

# 2. REDUCING THE PERIOD OF RECOVERY OF COMMUTATION AMOUNT:

Presently, commuted pension of Central Government employees as well as Bank employees will be restored after a period of 15 years. However, there has been a growing demand for restoration of the commuted pension after 12 years instead of 15 years by various retirees organisations including Bank retirees. Recently, the Punjab and Haryana High court has given a stay for recovery of the commutation amount in respect of the petitioners who have completed 10 years of retirement. The said order is applicable only in the case of petitioners who have filed writ petition in the High Court (Chander Mohan Tandon and others vs Union of India and another). Taking a cue from the stay, couple of retirees organisations have addressed a their Banks for stopping the letter to respect of all other recovery in pensioners.

In this connection, we feel that no purpose would be served by simply addressing a letter to the MD & CEO in the matter. The matter is already in

courts. Let us wait for the outcome of the case. Further. members need to appreciate that Central Govt has to take call in reducing the period of recovery of commutation amount from 15 years to 12 years and then our unions should take up with IBA and the Govt. for applying the same yardstick for Bank pensioners. OR alternatively a court judgement should come in the favour of reducing the period. Already, we have escalated the matter to our apex organisation AIBPARC and they are contemplating to approach the courts in the matter. Further, the Punjab and Haryana court has given a stay for recovery of the commutation amount only in the case of petitioners who are from Union Bank of India. We need to understand that pension regulations are common to all the Banks. Hence any favourable judgement in the case would be equally applicable to all the Bank will pensioners. Anyway, we be constantly watching the situation and jump into action if it is absolutely necessary.

3. Group Medical Insurance
Scheme for Bank Retirees: Your
CBROA has been demanding, inter alia,
a combined and composite medical
insurance policy for retirees as well as
serving employees since a long time. In
fact, last year, in our September
2023News letter, we have
proposed/demanded the following and
the same is reiterated below:

Retirees.

- There should be a composite/combined group medical insurance policy for both serving as well as retired employees/officers.
- 2. The sum assured of Rs. 4 lakhs fixed under Group Medical Insurance for officer Retirees was 8 years back. Since then, the cost of hospitalisation and charges for medicines and various medical procedures have gone up substantially. Hence there is an urgent need to increase the base amount to Minimum Rs.10 lakhs LIC. general as done bv insurance companies and SBI.
- 3. There need to be a reasonable cap on bed charges/ ICU charges and only critical illness like cancer, kidney, liver transplants etc. need to have a cap in order to keep the premium at reasonable levels.
- 4. GST on the premium paid by the retirees is a huge burden. We request the IBA/ UFBU/Retirees organisations to make an appeal to the finance minister for waiver of GST on Medical/Health Insurance policies of senior citizens. It would go a long way in helping the distressed geriatric

- population in India. This would be an enormously helpful gesture to the senior citizens of India.
- 5. Individual banks should subsidise the premium paid by their retired employees/officers. This demand is reasonable considering that 100% medical expenses incurred by the whole time directors of the Bank and their dependents are absorbed by the Bank during their lifetime.

Now, we understand that IBA has agreed to go for a combined medical insurance policy for both serving as well as retired employees/officers. It is a big step forward in the direction of affordable medical insurance policy for retirees. However, our fingers crossed! We hope the combined policy would result in substantial reduction in premium paid by the retirees. However, it is important to consider our other proposals too in order to have reasonable and an affordable medical insurance policy for retirees. We urge upon all the stake holders to seriously consider our proposals in the interest of retirees.




### VIJAYAWADA
