HAPPY 78TH INDEPENDENCE DAY. MAY THE TRICOLOUR FLY HIGH AND OUR NATION CONTINUE TO PROSPER

DEVASTATING LANDSLIDES IN WAYA-NAD DISTRICT OF KERALA.

On 30th July 2024, heavy rainfall triggered landslides in the Wayanad district of Kerala. The confirmed loss of lives has reached 392 people with further 150 people reported to be missing, in addition there were at least 273 injuries. According to environmental Scientists, human intervention including deforestation, unplanned construction activities and climate vagaries caused the devastating landslides causing destruction of human habitat and lives, flora and fauna. The major factors for this tragedy are unbridled quarrying, razing hills for constructions, massive scale road construction and expansion in the mountains and mono-crop cultivation, increasing tourism activities in the ecologically vulnerable areas. Incessant rains of high magnitude induced by climate change also caused the devastation. These grave human errors exacerbated the impact of the landslides.

The famous environmental scientist Madhav Gadgil, who was Chairman of the Western Ghats Ecology Expert Panel, has termed the disaster a man-made tragedy attributing it to Kerala Government's failure to implement crucial ecological recommendations. The Expert Panel has specifically warned against anti-environmental activities in the region. But the recommendations fell on deaf ears.

CBROA's heartfelt and deepest condolences go out to the bereaved families who have lost their loved ones. Our sympathies and prayers are with those who are injured grievously and those who have have survived.


INCREASE IN STAFF WELFARE EXPENS-ES OF PUBLIC SECTOR BANKS

At last, one more good news for serving as well as retired employees/officers. DFS has increased the limits of staff welfare funds of public sector Banks basing on business as

well as number of employees criteria. Limits were last fixed 12 years back in 2012. Thanks to the efforts of our parent organisation CBOA who have been taking up this issue in various forums and also our Bank writing umpteen number of letters/reminders to IBA /DFS to increase the limits. It has been a long pending demand of all the employees/ retirees and even after amalgamation of Banks in 2020, the old limits were not revised. Now, due to consistent pressure from various retirees organisations as well as trade unions, the limits were revised substantially by DFS. Earlier, we were enjoying a limit of Rs.45 crores (combined limits of Canara Bank and e-syndicate bank) in our Bank, now the same is enhanced to Rs 90 crores. In the previous financial year, thanks to CBOA and benevolent management of our Bank, Retirees could get a major share of the welfare fund. We hope and believe that the same trend continues in future too.



 6.To concentrate on Non members for Life member ship as retirements are coming down.






