UNIFIED PENSION SCHEME

Dear friends,

The Central Government introduced the Unified Pension Scheme (UPS) on 24th August, 2024 for the Central Government employees. The Scheme will be introduced from 1st April, 2025 and is expected to benefit more than 23 lakh Central Government employees.

The Scheme aims to provide stability, dignity and financial

security for the Central Government employees post-retirement, ensuring their well-being and a secure future.

Central The Government employees who joined the Central Government service after 01.01.2004 did not receive the benefits of the Old Pension Scheme (OPS) and they were under the brought National Pension Scheme. Old Pension Scheme was a defined benefit

scheme where employees received 50% of their past drawn salary as a lifelong pension, with DA adjustments twice a year. In NPS contrast is defined а contributory scheme where employees contribute 10% of their Salary and the Government makes matching contribution of 14%.

Eligibility:

*All the Central Government employees who have completed at least 10 years of service are eligible for the Unified Pension Scheme which assures a fixed pension amount.

- * Government employees who have completed at least 25 years of service are eligible to receive 50% of their last drawn average basic pay as pension.
- * Government employees who are covered under the National Pension Scheme and those opting for Voluntary Retirement Scheme under NPS.

The Scheme assures a pension of 50% of the average basic pay drawn during the past 12 months prior to superannuation for employees with a minimum of 25 years of service. For service

between 10 to 25 years the pension is proportionate.

The Scheme assures minimum pension of Rs.10,000/- per month on superannuation, provided the employee has completed at least 10 years of service.

The Scheme provides a guaranteed family pension equivalent to 60% of the pension drawn by the employee immediately before his/her demise.

The Scheme also includes inflation indexation and a lump sum payment upon superannuation. This lump sum payment will be equal to one tenth of the monthly emoluments I e Pay as on the date superannuation for every six months of completed service. This will not reduce the amount of assured pension.

The Government / employers will contribute 18.5% of the basic pay + Dearness Allowance, while employees will contribute 10% of the Basic Pay + Dearness Allowance every month.

The Unified Pension Scheme draws features from both the Old Pension Scheme and National Pension Scheme. UPS provides assured pension, minimum

family pension and pension, providing retired security to offers employees. lt also protection against inflation by adjusting the Dearness Relief of the employees.

This Pension Scheme is clearly aimed at addressing the perceived shortcomings of the NPS among a large section of Government employees. When the NPS was introduced first in 2004. completely the revamped prevailing pension architecture, now referred to as Old Pension Scheme, For Central Government employees joining service after 1st January, 2004, the NPS replaced the assured monthly pension of the previous "defined benefit" with market-linked reaime. а vehicle in the shape of a "defined contribution" scheme. In simple terms it shifted the burden of retiral payouts from the exchequer to the capital market. However, it also took away the fixed security net the Government employees were used to in the previous regime. Today notwithstanding the stock market boom in recent vears, those retiring under the NPS are convinced that their retiral benefits are at risk, and that they could end up fetching a much lower pension than the one they would have received under the OPS.

Effectively the UPS offers a hybrid model featuring the fixed benefit of the OPS, along with a contribution based, market-linked component akin to the NPS. This provides the employees with both a guaranteed Pension and the possibility of high returns. Clearly, for any Central Government employee desiring a guaranteed, predictable income stream after retirement, the UPS is definitely a go-to option.

The introduction of UPS by the Union Government for employees marks a significant change for Govt.rmployees. The Scheme ensured that the employees can consider sound financial planning for retirement. While UPS is not a return to OPS. it is a step towards securing and ensuring the future of employees. The UPS represents a policy shift, balance fiscal aiming to responsibility with the need for a secure and predictable pension system for Govt. employees.

The State Governments can also adopt and implement the UPS Scheme for State Government employees. Maharashtra is the first state to implement the UPS for State Govt.employees on 25th August 2024. If all states adopt the UPS Scheme, it could benefit over 90 lakh Government employees currently covered under the NPS Scheme across India.

Our Apex Body AIBPARC has already taken up the issue of implementing the Unified Pension for all those Bank Employees who joined the services of Bank after 01.04.2010. These employees have been covered by the National Pension Scheme.


Our Apex Body AIBPARC has been campaigning for reduction of the Qualifying Service for full pension from the present 33 years years. Now that to 20 Government has fixed the qualifying service for full pension at 25 years, there should not be any impediment for fixing the Qualifying Service of 25 years for full pension for Bank employees. As the Central Pay Commissions have been improving the pension structure for Central Government employees, updation of pension

for Bank Employees which is hanging fire for the last 30 years, should also be considered by the Central Government.

Our campaign to clinch these benefits for Bank employees will continue under the banner of our Apex Body AIBPARC.

We wish all our members and their family members a very happy and joyous Ganesh Chaturthi.

CBROA BLR CIRCULAR 4/2024

Sub: Restoration of the Commuted Portion of Pension

Bank Employees Pension Regulations 1995 - sub-regulations 41(4) and 41(5) provides for an employee to be entitled to commute a portion of pension not exceeding one-third of the pension. The lump sum amount payable to a pensioner is calculated in accordance with the table showing commutation value for a pension of Re. One per annum, which for a pensioner superannuating at the age of 60 years is shown as 9.81. In other words, a person who is retiring on superannuation and commuting his pension would receive in advance an amount equivalent to aprx. 10 years of his commuted value of portion.

Regulation 41(5) further provides that the commuted portion of the pension shall be restored after the expiry of the period of **fifteen years** from the date of commutation.

It has always been a subject matter of contention that when the lump sum amount payable to a pensioner opting to commute the admissible portion of pension for ten years, why the commuted portion is to be restored after 15 years instead of 10 years. The Pension Regulations 1995 do not contain any basis or justification for continuing the recovery up to 15 years. However, it must be noted that there will not be recovery of the commutation amount from the family pensioner upon the death of the pensioner. The idea to stipulate recovery for 15 years could be to cover this risk factor and eventualities. Moreover, in the case of those who retired well before the date of superannuation will get a higher commutation amount (the commutation factor goes up to 13.25 to those who take VRS at the age of 50) and pay less.

Though the commutation factor and percentage of pension to be commuted differs vis-à- vis Central/State Govt. employees, the period of recovery of the commuted value of pension remains the same i.e. 15 years in respect of both the Bank as well as Central/State Govt. pensioners.

In October 2022, State Government of Gujarat took a decision for reduction in the period of restoration of the commuted portion of Pension to 13 years for its employees.

It was in this backdrop that some pensioners of the Government of Punjab followed by the Pensioners of the Haryana Government approached the Hon'ble High Court of

Punjab and Haryana at Chandigarh and the High Court granted an interim stay on recovery of commuted portion of pension after completion of ten years from the date of commutation. Those respective Governments have already honoured the orders of the Hon'ble High Court and have issued instructions to stop recovery of the commuted portion of the pension for all those who have completed 10 years after the date of commutation subject to final orders from the Court.

Consequent to these developments, the Bank Pensioners falling within the Territorial Jurisdiction of the Hon'ble High Court of Punjab & Haryana, Chandigarh encompassing the States of Punjab & Haryana and Union Territory of Chandigarh also approached the Hon'ble High Court, Chandigarh, invoking Regulation 41 of the Bank Employees Pension Regulations 1995 and the Hon'ble Court granted similar stay order directing the respective Banks to stop recovery of the commuted portion of the pension for all the petitioners who have completed ten years from the date of commutation.

On similar petitions filed in different High Courts by the Pensioners of Defence and Railways, similar relief has been given by respective High Courts.

Though the pension regulations with regard to restoration of commuted portion of pension after 15 years from the date of commutation has been existing since 1995, no one whether UFBU, AIBOC or any retirees' organisations have raised this issue until the Gujarat Govt. reduced the period of restoration to 13 years.

Now, thanks to many such persons who are doing a yeomen service to the community of retirees by flagging this issue by approaching the Court of Law and getting an interim stay for stopping the recovery of the commuted portion of pension. We sincerely thank all these persons for flagging this issue and approaching the Courts for relief.

It is further submitted that the Banks are implementing the Order of the Hon'ble High Court, Chandigarh only in respect of the petitioners. When similarly placed pensioners having completed ten years or more from the date of commutation applied for stopping the recovery from pension, the Banks are declining their request.

Subsequent to this happening, the Retirees of different Banks staying primarily in Punjab, Haryana and the union territory of Chandigarh formed homogeneous groups of similarly affected persons and approached the same HC and got favourable orders in favour of themselves restraining the respective Banks to stop recovery on completion of 10 years. As a sequel to this, being encouraged by the outcome of the proceedings for obvious reasons, the Retirees of different Banks approached the High Court of other states (for instance Kerala HC) and got favourable verdicts in the same line as stated above.

Our Apex organisation AIBPARC has been vigorously following up with IBA/DFS/Finance Minister and requesting them to accept the court orders and advise the Banks to stop recovery of commuted portion of the pension on completion of 10 years after availing the same. Unfortunately, UFBU/AIBOC and many other retiree's organisations are maintaining a silence in the matter, for the reasons best known to them.

It is also surprising and perplexing that IBA and MOF are mute spectators and maintaining a strategic silence and not initiating any action to help the retirees, forcing the senior citizens to approach the Court of Law by spending their hard-earned pension.

In the meanwhile, due to pressure from some affiliates and retirees who have completed 10 years of service, AIBPARC had been in regular touch with the Lawyers to explore the possibility of approaching the Court of Law in their representative capacity to seek similar such relief for all the members of their affiliates who are similarly placed. However, the Lawyers are insisting on furnishing the very list of the names of members who are affected with certain details of each member. Since the number of beneficiaries in the total membership being too huge, it was felt that it is going to be a complicated and a very exhausting exercise for AIBPARC as an Apex body of Bank Pensioners and Retirees with a very large membership. Further, the legal costs involved too are exorbitantly high as the lawyers are asking for a certain fixed sum of fee per member, which collectively runs into several lakhs of rupees. In view of the foregoing, AIBPARC has advised the affiliates to consider the feasibility of their approaching the Court of Law on behalf of the eligible members of their members and such legal recourse can be tried before the Hon'ble High Courts of Punjab and Haryana and Kerala where already Stay Orders are obtained.

In the above backdrop, many of our members, especially those who have completed 10 years after retirement, are seeking clarification and requesting us to file a suit on behalf of the affected retirees.

Friends, in light of the above, we opine/advise as under:

We are having 3600 members who have completed more than 10 years after retirement and are eligible to seek relief from the Courts. Now, if we have to approach the Court of Law, we need to collect a certain set of documents and also the requisite fee from the concerned members. The exercise involves humongous/arduous task of collecting the data from these members. The number of beneficiaries in the total membership being too huge, it is going to be a complicated and a very exhausting exercise for CBROA with a very large membership. The legal costs involved too are exorbitantly high as the lawyers are asking for a certain fixed sum of fee per member, which collectively runs into several lakhs of rupees. Further, the number of eligible pensioners is dynamic in nature. The number keeps changing with each passing day- many may come in the bracket of completing 10 years and many others would be completing the 15-year period. How to manage the

same? Further, many of our members whose commuted portion has already been restored are seeking a refund of the amount already recovered!

It is a catch 22 situation for us. We all know, how courts function and there is no definite time frame within which we can get a judgement. It may take several years for the courts to pronounce the final judgement as it is happening in pension updation case.

It is further clarified that in case of any relief to the retirees in final order, it could be implemented only after the Pension Regulations are amended accordingly. An important aspect of the case is that whatever decision emerges from the court, will apply to all retirees. Article 14 & 15 of the Indian Constitution enshrines the guarantee of equality before law and prohibition of discrimination. While there may be temporary relief through interim stays for a few, the facts suggest a different picture.

It is a matter of understanding that any petition filed in a court of law is decided on its own merits. Simply getting the stay referring some other petition where Hon'ble Court has already granted the stay, does not serve the purpose in final disposal of the petition. There is a raging debate with regard to the recovery of commuted portion of pension for 15 years even though the entire commuted portion of pension is recovered in less than 10 years. Unfortunately, the regulation doesn't provide for any basis for the same. One argument is that it is linked to charging nominal interest on the lumsum commutation amount which works out to 6.1% for bank pensioners. Another argument is that it might have been linked to the life expectancy of the retiree which was around 60 years during 1995-2000. If we take this argument, then while introducing pension scheme in Banks, the commutation allowed was purely a welfare scheme, where majority of pensioners were not expected (anticipated) to pay back full amount disbursed as commutation. Hence higher commutation factor is allowed to those who take VRS, few years prior to superannuation. Now, the average life expectancy is around 76, the entire commutation amount would be recovered from 90% of the pensioners. Hence, time has come to review the 15-year recovery period. In all fairness, the recovery period shouldn't exceed beyond the recovery of the entire lumpsum amount given as commuted value of pension.

In CBROA, we have already burnt our fingers by spending huge money on pension updation case in high court of Karnataka. Our case is yet to come up for hearing even after couple of years. AIBPARC is also fighting the pension updation case in Supreme Court which is getting adjourned regularly and hapless retirees are still waiting to get justice from the courts!

Friends, we being the trade unions representing lakhs of retirees, if we start approaching the courts for resolution of our legitimate demands, then where it will end? We are retirees' associations with limited funds and infrastructure. Do we have the wherewithal to keep fighting the legal cases on behalf of our members?

We feel that the best way forward for the apex body/affiliates is to take up in right earnest with the Govt/IBA and resolve the issue. The issue of early restoration of commuted portion of pension affects not only the pensioners in banking industry but also all the central and state Govt. Pensioners. Hence it is better to co-ordinate with all the retirees' organisations and take up this issue jointly with the finance minister for early resolution. We feel that ultimately, it is a political call- Finance Minister has to consider the legitimate demand of millions of pensioners belonging to central/state Govts/Banks and other public sectors. Hence, let us all join together and bring pressure on the powers that be.

Further, we also note that because of some petitioners approaching the High court of Punjab and Haryana and got a stay in the matter, this issue is being flagged and several other retirees/groups of retirees are approaching the courts and getting a stay. Since the stay orders are applicable **only in respect of the petitioners**, if any of our members/group of members take a call to approach the court in their individual capacities we would definitely help them in filing a case in the high courts of Chandigarh and Kerala.

We stand firmly for the welfare of retirees. We need to wait for Banks/IBA's reply until the next hearing on 18.10.2024.





TRIBUTE TO LATE SRI H R SHENOY BY SRI B SUDHAKAR SHETTY, FORMER GS CBOA AND MAN BEHIND FORMATION OF CBROA.

Mr H.R.Shenoy fondly known as Rohidas, laid strong foundation for building mighty, vibrant CBOA unit in erstwhile Delhi region consisting of eight states. He has travelled length and breadth of north Indian state branches for consolidation of CBOA units on number of occasions-travelling in unreserved compartment in second class. He was the Regional Secretary and Circle Liaison for more than a decade. Subsequently he was elected all India secretary and member of apex level negotiating team (C.N.T).

He was in forefront of CBOA agitation in Delhi i during 1982-83 aginst the management for violating the agreed transfer and promotion policy. It is memorable to mention here that he

organized Dharna in front of Delhi Circle from dawn to dusk with mammoth gathering of north Indian members against the victimization of transfer of CBOA leaders. The slogan shouted on the occasion is still ringing in my ears.

He was the valiant soldier of CBOA and responded the organisational call of CBOA given to all the CC members and office bearers till the restoration of bilateralism.

After the impasse, he played an active role in instituting the circle level joint conference and circle level liaison for redressing the grievance of officers which resulted in further growth of CBOA in the region.

He played a vital role in coordinating the case filed in Supreme Court on CBOA trust matter in 1984 which materialised in retaining valuable property in Chamarajpet, Bangalore. Not only the property retained by CBOA but disciplinary action contemplated against the office bearers was re looked by the management. He developed a strong second line in Delhi circle CBOA unit and two of the office bearers became General Secretaries of CBOA.

He has risen to the top executive of our beloved bank and continue to guide the second line leaders for responsive and responsible officer movement.

No doubt, it is a rare occasion in one's career to become a good comrade, Circle level liaison, a member of CNT and to reach top management scale VII.

He was able to attain the above due to his hard-work, commitment, and sincerity whichever the sphere he worked and organised. I had more than a decade close association with him in CBOA and lost a good friend.

He was the first top executive to appreciate me and late Sri Gajanana Rao and late Sri P. Sanjeeva Rao when we formed CBROA which was registered under trade union act. CBROA is now emerging as a strong welfare association which has achieved many improvements in pension scheme. CBROA was close to his heart and he was very much concerned about the senior retirees.

May his soul rest in eternal peace.
