



# OCTOBER 2024 FROM THE DESK OF GENERAL SECRETARY



Dear Members/Associate Members.

Come the month of October every year there will be a spate of anxious enquiries with regards to the Health Insurance Policy to be floated by the IBA. Many of our members indulge in some speculative exercises on the premium amount. The pensioners and retirees of our Bank have been relentlessly arguing that the Bank should float a common Health Insurance Policy for both the serving employees and retirees. They have also been debating continuously that our Bank should subsidise the Health Insurance premium to a large extent. We are happy that both the above aspirations have been realised, thanks to the concerted efforts

of our beloved MD & CEO at IBA level in introducing a common policy for the serving employees and retirees of the Our Management has also conceded our demand for subsidising the health insurance premium to the 6.000/-. extent of Rs. These developments have taken place on account of relentless campaign waged by CBROA and the proactive stand taken by our MD & CEO who has acceded to our demands. We thank the Management for this nice gesture, which has resulted in substantial reduction in the premium amount to be paid by the pensioners/retirees of our Bank.

As we move through life one concern remains constant: our health.

Transitioning into golden age comes with its health challenges. Under such circumstances it is essential to realise the diagnosis and treatment costs that come with it. Old age brings with itself ailments which several are expensive to treat and care for. As the age advances, the immune system becomes more fragile with time and slowly operates as one ages. This raises the likelihood of being a host to different diseases or being afflicted with certain critical illnesses. If statistics are to be believed around 47% of India's Senior citizens suffer from at least one chronic disease such as diabetics, hypertension, depression, asthma, arthritis or angina.

After retirement the retiree will have limited income by way of monthly pension and income coming from investments made. Α medical emergency often comes unannounced. A single instance of hospitalisation can wipe out the entire life's earnings. Medical expenses can become a substantial financial burden in no time considering the medical inflation which is at an all time. Health care costs are constantly rising in India. Reports say India's medical inflation that increasing at 15% every year, almost double the overall inflation rate. It means that a heart surgery that costs Rs. 2 lakh

today will cost approximately Rs. 5 lakh after five or six years. Hence, it is crucial to understand that a comprehensive health insurance policy is not just a choice but a necessity for everyone. It protects the insured from incurring exorbitant health care expenditure and ensures that the insured gets necessary medical treatment when required.

We hope the health insurance premium which has been substantially reduced will enable all our members, particularly the family pensioners to subscribe to the IBA Group Mediclaim Policy and enjoy peace of mind as far as their health issues are concerned.

Our commitment to bring further relief to all our members and all the retirees of our Bank will continue unabated.

We wish all our members and their families a Happy, Joyous, Healthy and Prosperous Deepavali.

SUB: MEGA MEMBERS MEETING AT BENGALURU ON 6TH OCTOBER 2024

Dear friends,

Today's (6th October 2024) members meeting held at Bengaluru was a huge success. The meeting was attended by more than 800 members. The auditorium was jam packed and many members were standing outside the auditorium. Chief Guests Sri Surendran, CGM, HR Wing, Head office in his speech mentioned about the Bank's business position and requested the members to opt for Jeevan Dhara scheme. He spoke about the benefits given to retirees especially cross subsidising the Group Medical Insurance Scheme and huge reduction in the premium from Rs. 77000/- to Rs.41000/-on account of the combined policy for serving as well as retired employees/officers. General Manager, Bengaluru circle Sri Mahesh Pai spoke about the Circle's business position and his happiness in attending the retirees meet and sought support from all the retirees and their family members for garnering business especially CASA for the Bank. General Secretary in his address explained the various issues of retirees especially the IBA's Group Medical Insurance scheme, Super top policy offered by K M Dastur, Status of pension updation, Restoration of commuted portion of pension, reckoning special allowance component for pension and also touched upon CBROA's various initiatives and its role in clinching various benefits for its members and its membership strength, donation, organisational soundness etc. He praised the Canara Bank MD & CEO for his role in convincing IBA to go for a combined group medical insurance policy this year, which resulted in 47% reduction in the premium paid by the retirees vis-a-vis previous year's premium. He also thanked CBOA GS Sri. Ravikumar who constantly pursued this with Canara Bank management and bringing the issue to its logical end. The highlight of the meeting was the presence of our beloved MD & CEO, Sri K Satyanarayana Raju who spoke at length about the Bank's business position especially the CASA position and requested the retirees to help the Bank in increasing its CASA ratio, which is the only weak business parameter of the Bank. He declared that all retirees are brand ambassadors of our Bank. He said that retirees being senior citizens should guide the young employees and officers and try to understand them as there is a generation gap between them and the present workforce. He

mentioned about some videos circulated by WhatsApp university in retirees groups and in social media and request the retirees to desist from doing such things which give bad publicity to the Bank and tarnish its image. He said Bank as an organisation is sacrosanct and like mother to all of us. He spoke about the couple of benefits extended to retirees when CBROA took up such issues with them, especially the 50% concession given to small and medium lockers hired by retirees and extending the same to all family pensioners too. He also announced the following benefits for retirees under this year's staff welfare measures.

- 1. Rs. 6000/- will be given to those who are opting for IBA's Group Medical Insurance Scheme.
- 2. Rs.3000/- will be given as medical reimbursement for all others.
- 3. A new scheme viz funeral expenses for retirees is introduced wherein Rs.10,000/- will be paid to the spouse/legal heirs in the event of death of a retiree.

Friends, all the above have been pursued by CBROA with the Bank management regularly and we place on record our appreciation to CBOA GS Sri. Ravikumar for effectively taking up the proposals and achieving the same. Our heartfelt thanks to our MD & CEO for extending the above benefits to the retirees.

During the meeting, CBROA felicitated about 70 persons who attained the age of 75+. Many members have expressed their happiness in arranging such a mega members meeting and hailed the tradition of CBROA in felicitating members who attains the age 75+ and 90+ years. All the members were very happy about the lunch provided and the efforts put in by the Bengaluru team members of CBROA in organising such a beautiful and memorable meeting.

CBROA CIRCULAR 7/2024

SUB: ENROLMENT TO GO DIGIT INSURANCE - SUPER TOP UP POLICY (OFFERED BY M/S K MDASTUR REINSURANCE BROKERS PVT.LTD.) - ONLINE SUBMISSION

REF: OUR CIRCULAR 6/2024 DATED 09.10.2024.

We kindly request all our **members** to go through the contents of this circular and all the annexures (policy details of Go Digit Insurance /brochures, FAQs) and fully understand the salient features of the super top policy of Go Digit Insurance Company and then take a call to subscribe basing on your health cover needs. We reiterate that CBROA is only a facilitator for helping interested members to subscribe to the policy since the policy is issued in the name of CBROA for its members.

Please go through the following before applying for super top policy:

Please note that only the members of CBROA should subscribe to the policy through the link, by selecting "CBROA" under column Association in the online form. Any non-member (officers only) who wish to avail the facility should first become member of CBROA.

- I. Operational guidelines for retiree to avail super top policy of Go Digit for 2024-25 areas under:
- a) It is available in multiple slabs from 1 to 10 lakhs.
- b) It is standalone policy. It is not necessary for the retiree to take base policy to availthis policy. Threshold limit is Rs. 3 lakhs.
- c) Period covered under this policy is from 1.11.2024 to 31.10.2025
- d) Window to exercise this option will remain open from **14.10.2024** to **15.11.2024**. Those who subscribe to the policy up to 28.10.2024, will be covered from 1.11.2024 to 31.10.2025. Those who avail option from 29.10.2024 and up to 15.11.2024, they will be covered from 20.11.2024 to 31.10.2025 and shall be added to the same policy via an endorsement.
- e) The policy will be issued in the name of CBROA -CANARA BANK RETIRED OFFICERS' ASSOCIATION for the members of CBROA.

- f) Retirees who wish to avail the policy will be required to fill up online form giving required information in it. Detailed power point presentation giving guidelines to fill up the form is attached with the circular.
- g) Prescribed payment of premium may be made online through Debit/ Credit cards or online banking or RTGS. Payments can also be made by cheque. Cheques may be issued in the name of insurance company, Go Digit General Insurance Company Limited. Cheques can be deposited at the collection centres of broking firm, K. M. Dastur Reinsurance Brokers. List of collection centres is attached.
- h) This policy is being handled by M/s K. M. Dastur Reinsurance Broking Private Limited, Mumbai. Details of contacts of KMD officials (location wise) are available in the annexure. For any assistance for deposit of payment, you may please contact the concerned officials of your area/location mentioned in the KMD location list.
- i) Health Cards will be issued online and may be downloaded by the individuals. Detailed instruction in this regard will be issued separately shortly.
- j) Policy documents will be uploaded on web site of broking firm and insurance company for information and knowledge of the retiree.
- k) Since many retirees faced issues last year with 2 different TPA's during cashless, we have brought an improvement by doing away with the TPA in our super top up policy. Go Digit has taken the responsibility of processing claims directly. Go digit has a robust in-house team of claim processors and a tie up with over 13000 hospitals across the country who are attached to them through an online portal. This will reduce the turnaround time for claim settlement and increase efficiency as DIGIT gives cashless within 45 minutes.
- l) Cashless facility will be available at networking hospitals of Go digit. Please note that there are several hospitals which are not in the panel/de-empanelled. Retirees who will be availing the claim must be careful in getting admitted to only empanelled hospitals. In case, if they get admitted to any deempanelled/blacklisted hospitals, reimbursement of the claim will be rejected.
- m) To assist retirees in obtaining approval of Go Digit for cashless facility and to obtain necessary documents from TPA appointed by IBA, KMD has appointed team of personnel. Names and contact number of these officials shall be announced shortly. These officials shall be present at each of the KMD branches to give complete and thorough assistance. Further Go Digit will also give region wise personnel to guide retirees for every detail.
- n) Go Digit is a completely digital company, and claims can be submitted online via WhatsApp. There will be no requirement of hard copies. This will be considerably easy for the retirees. For those who cannot submit online hard copies will be accepted at KMD / Go digit offices.

### **LINK FOR ENROLLING TO SUPER TOP POLICY OF GO DIGIT:**

We are furnishing the link forOnline Application form (web-form). The link is also sent separately in all our WhatsApp groups. You can copy the link and open it in your laptop/mobile and submit the online enrolment form for subscribing to Super Top up policy of Go Digit. Please note that link will become available online from 14.10.2024. For those who want to pay by cheques, they can submit the form offline and deposit the cheque at KMD collection centres.

Important Message from M/s. Dastur:

It is always better to make payment online. Please note that all those retirees who want to pay by cheques should drop the cheques at KMD collection centres after submitting the formsoffline. we shall be opening many more collection centres across India. Retirees should not directly deposit them in ICICI bank account, if they put in a wrong code or no code is mentioned, the cheques will be difficult to trace and reconcile. They may courier to our nearby centre. They may also pay during any of our meetings held.

Please note that payment of super top policy premium is directly made to Go digit. Hence, CBROA is not responsible for any wrong submission of applications offline/online or any wrong deposit of cheques and consequent rejection of applications.

He urged upon the members in general and the office bearers, in particular, to enrol new members and also emphasised on enrolling spouses of existing members Associate as Members. complimented all the organisations in their fight for improving family pension, 100%. DA neutralisation and thanked the IBA/Finance Ministry and all others concerned for making these demands come true. This has helped in improving the pension amount to the concerned class of retirees.

Further, he informed that the financial position of CBROA with the corpus of Rs.5 crores on hand and the income earned therefrom is sufficient to meet conducting the expenditure like meetings, other day to day expenses. The serving employees are not keen on this since they are covered under NPS and contribution from the employer and employees is on Basic plus DA. During the present bipartite, for the current bipartite period exgratia is being paid without prejudice to updation of pension. Commutation of Pension - While explaining the genesis of commutation. commutation factor for Central Government employees, bank informed that employees. he the demand for restoration of commutation in 10 months and 8 months and so on gained momentum with the Gujarat Government passing an order to recover commuted pension in a shorter period. Enthused by this certain individual bank retirees approached Courts Chandigarh and Kerala and obtained stay orders. There was pressure from the retirees to initiate legal action from apex level. AIBPARC has recently come out with a circular informing that they are not contemplating any such action. However, it is informed that their constituent members can do so if thought fit and they would extend required support.

On the IBA medical insurance policy, the General Secretary placed on record his sincere appreciation of the favourable stand taken by our Bank's CMD in obtaining a combined policy for the serving employees and retirees. In view of this, IBA has since called for quotes for the combined policy from insurance companies and the same is in process. He informed that there would be reduction in premium to the extent of 15 to 20%. 


