## NOVEMBER 2024 FROM THE DESK OF GENERAL SECRETARY



### A journey Par Excellence

Dear Friends/Associate Members

Our warmest Greetings to all of you on the joyous occasion of 119th Founder's Day.

While our beloved Bank's marking its 119th Founder's Day is laudable, our Founder the most venerated Ammembal Subbarao Pai's achievements stretch beyond the Bank and need recalling for the new generation. One hundred nineteen years ago, a man with rare courage ventured on the first steps to start a Bank in Mangaluru. Realising that smaller small traders borrowersand peasants - were at the mercy of money lenders who were charging interest in excess of 50%. he Moreover. realised that traditional channels for savings were not entirely risk-free and that a longer institutional framework would not only protect and reward savings but also provide a profitable avenue for credit that

would challenge the stranglehold of the money lenders in the rural areas.

In the early 1900s Arbuthnot Company, which collected deposits from the Public and gave crashed and loans. caused widespread distress South in Canara District. Many families lost all their savings in the crash. The smaller business people found it very difficult to get credit except at prohibitive rates of interest. Our Founder foresaw disaster ahead, if the community did not mobilise its own resources to help itself. The result was the starting on July 1st, 1906 of the Canara Hindu Permanent Fund Ltd. which was later to become Canara Bank. The venture proved an instant success. That so soon after the crash of Arbuthnot, the people entrusted their savings to the newly started institution, is an eloquent testimony of the trust people had in our Founder.

The venture established with 2000 shares of Rs.50/- each was one of the first joint stock companies to be floated in South Canara District. It is pertinent to note here that our Founder toured the entire South Canara District in bullock cart to mobilise the capital fund for the venture. The Public supported the venture whole heartedly. During that particular time it was

not just the money lenders who were its competitors. The area was already serviced by Bank of Madras which enjoyed а significant presence in southern coastal Karnataka at that time. Our Founder did not see the incumbent bank a threat as because he realised that Bank of Madras catered almost exclusively to the large merchants and landlords and was not accessible to those lower down the social and economic strata. This was apart from the fact that Bank of Madras charged high interest rates from borrowers. Our Founder set the following principles while starting the venture: " A good Bank is not only the financial heart of the community but also one with an obligation of helping in every possible manner to improve the economic conditions of the people". common These loftv thoughts symbolise a legacy of unwavering dedication and serve as a beacon for the present generation to uphold the values cherished by our Founder.

The bank gone through has various phases of its arowth trajectory over hundred years of its existence. Α rash of Bank collapses in India in the 1920s and 1930s, most notably that of the Travancore National Bank and Quilon Bank in 1938 resulted in a loss of confidence but Canara Bank remained unscathed. It is evident that Canara Bank had emerged unscathed from the period of intense uncertainty in Indian banking, when smaller banks were struggling to remain on their feet in conditions that were aggravated first by the great Depression and then by the gathering war clouds.

Growth of Canara Bank was phenomenal, especially after nationalization in the year 1969, attaining the status of a national level terms player in of geographical reach and clientele segments. The eventful journey of the Bank has been characterised by several memorable milestones. Today Canara Bank occupies a premier position in the comity of Indian Banks. More than a century later Canara Bank continues its journey as a premier Bank in India, one that pairs traditional prudential values so essential for a systematically important institution with the daring of embracing modernity.

Our founder was a visionary far ahead of his times and life, he became a living soul and his philanthropic zeal continues to touch the lives of innumerable people even today. A lawyer and banker by profession, an educationist by temperament, he was the foremost among the preindependence luminaries who shaped the future of South Canara District and India. His concern for social upliftment, gave birth in 1891 of the Canara High School at Mangaluru, the century old precursor to the conglomeration of Canara Educational Institutions, of today. He started Canara High School for girls in 1895 which was a revolutionary step at a time when educating the girls was a taboo. The seeds sown by the Founder more than a Century ago have grown into huge banyan tree providing shelter to the society in terms of education, employment opportunities and financial support to the welfare, prosperity and progress of the society.

We are very happy to note that our MD & CEO has decided to commemorate the occasion by displaying in every branch, the journey of our Founder in a bullock cart to mobilise Capital Fund from the general public in South Canara District. This step being taken to create awareness among the present generation of employees of our bank about the humble beginnings and the strugale waged by our Founder to build this areat institution. Our Founder Sri Subba Rao Pai has remained an enduring source of inspiration across generations. This is a great tribute to the visionary.

We wish all our members and their families a very healthy, happy life for all the days ahead.
