FROM THE DESK OF GENERAL SECRETARY



Dear Members/Associate Members,

During our interaction with many of our members, we have come across many of them suffering on account of loneliness and social isolation. Some of them expressed that after passing away of their life partner, they felt like they had lost their anchor or their life support. With emergence of nuclear families, children having gone to distant shores in search of better job opportunities abroad, children having their own life to lead and they hardly have an opportunity to see them or speak to them, has left the elderly in a state of loneliness. This

story is symbolic of millions of elders in India who themselves are grappling with the absence of meaningful human connection.

Loneliness among the elderly is a silent epidemic that affects not only India but also the world. India has the second largest global aging population and it ranks third among countries with the highest rate of loneliness in older adults.

Even in a world where social media and technology are fostering

relationships, loneliness still persists and affects the elderly the most. The hidden battle of loneliness among the elderly often goes unrecognised as we navigate the fast-paced rhythms of modern life but its impact on mental health is significant and widespread.

Although aging is a necessary aspect of life, it frequently brings about major changes that might lead to isolation from society. The severe emotion of loneliness that many seniors endure can be aggravated by retirement, physical restrictions, the loss of a spouse or friends and geographical separation from loved ones.

It is alarming how loneliness affects mental health. Various studies have shown that loneliness in elderly people is associated with a higher risk of anxiety, sadness, mental decline and even physical health problems including immune system weakness and cardiovascular disease. Lack of social engagement can exacerbate emotions of helplessness and deepen the cycle of loneliness by impacting cognitive function.

Loneliness might also have medical implications in addition to being a psychological burden. Prolonged isolation causes the body to go into stress mode, which raises stress hormone levels and can eventually be

harmful to general health and well-being.

Finding successful solutions for tackling senior loneliness requires an understanding of its varied character. Loneliness can be substantially decreased by programmes that promote intergenerational activities and community involvement among elders.

Promoting community engagement via volunteer work, clubs or senior centres, helps people feel like they belong and have a purpose. Intergenerational programmes are beneficial to both the elderly and the younger participants, because they foster meaningful connections and challenge age related preconceptions.

Also it is priceless to use technology to close the generational divide. Seniors who are taught how to use online forums, video calls and social media can feel less alone because they are able to maintain connections with their loved ones and the wider community.

It is crucial to assist the elderly in continuing to lead active social lives. By routinely checking in, investing quality time and participating in socially engaging activities, bring in touch with family members and

neighbours may make a big difference.

Elder loneliness is a heart-breaking reality that has to be addressed. To deal with this silent epidemic empathy, compassion and proactive measures are essential. We are all capable of working together to create a society where our seniors feel appreciated connected and cherished by promoting inclusive communities. We have introduced the concept of honouring our members when they attain 75+years of age, again when they attain 90+ years of age and ultimately when they attain 100+ years of age, in the meetings attended by a large number of our members. This programme has been providing an opportunity to all our members to meet their old pals and exchange pleasantries, go down the memory lane and remember the good old days of their career in the Bank.

Let us not let melancholy cast a shadow on the knowledge and experience of our Senior colleagues. Let us work together to create a society where our elders are respected, heard and enveloped in a loving network of companionship.

We wish all our members a Happy Rama Navami, Ambedkar Jayanthi, Mahaveera Jayanthi, Akshaya Tritiya and Basava Jayanthi which are celebrated during this month. We also wish our Christian Brothers and Sisters Blessed Friday. Also extend wishes to our Muslim brothers and sisters on conclusion of Ramadan.

We wish all of you a healthy, happy and joyous life.

CBROA Welfare Schemes: (Effective from 09.04.2025)

I. Medical Relief Scheme (Reimbursement of Hospitalization Expenses):

Objective:

To assist the member/spouse by way of reimbursement of Hospitalization expenses for any ailment /disease /accident to the member or his /her spouse.

Eligibility:

All the life members are eligible for the scheme. The benefit of the scheme will be **available one year after** becoming a life member of the Association.

Maximum Limit Under The Scheme:

Maximum limit for each member is **Rs.30000/-** during his/her lifetime (a sub-limit of **Rs.10,000/-** would be made available for the spouse of the member, **provided he/she is our associate member.**)

Threshold Limit:

Minimum hospitalization expenses incurred must be **Rs 3, 00,000/- (Rs Three Lakhs only)** under **single hospitalization bill concept**. Investigation / Medicine expenses incurred pre and post hospitalisation (**up to 30/90 days** respectively. However, in respect of cancer and kidney ailments up to 365 days post hospitalisation expenses) will be considered as hospitalisation expenses for reimbursement purpose.

Other provisions:

- In respect of members who are covered under medical insurance scheme, 100% of the disallowed portion over and above the hospitalisation bill of **Rs.3 lakhs and above** (per hospitalisation bill) will be reimbursed.
- In respect of members who are not covered under any insurance scheme, reimbursement will be made at **50%** of the amount over and above the hospitalisation bill of **Rs.3 lakhs** and above (per hospitalisation bill).
- Each claim under the scheme is subject to a minimum reimbursement of Rs 5000/-. For example, if the reimbursable amount is Rs 4,500/-, no reimbursement will be made.
- Members may prefer **maximum 6 (six) claims** during his/her lifetime, including claim for his/her spouse, subject to the overall limit of Rs.30000/-
- Hospitalisation claims shall be made within a reasonable period of **6 months** after discharge from the hospital/settlement of insurance claim. (However, reimbursement may be considered before discharge, if the interim bill exceeds more than Rs 3 Lakhs, during the hospitalisation period).

II. Honoring of Members who have attained the age of 75+,90+.100+ years:

Members who have attained the age of 75+ years, 90+ years and 100+ years will be honored at Triennial Conference/various meetings conducted at different cities/places. In case the members are unable to attend such conferences or meetings, our office bearers/activists will call on such members at their residences to felicitate them.

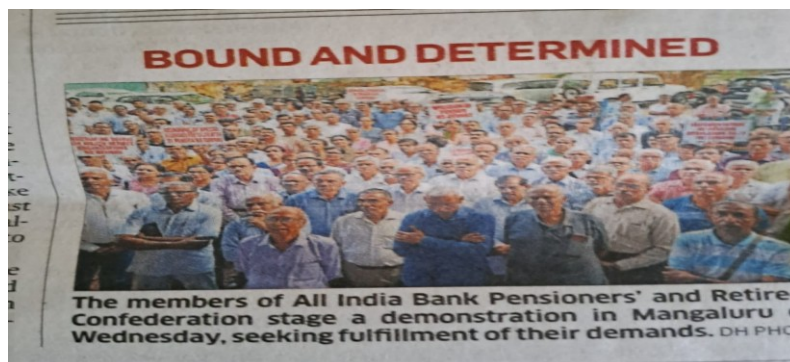

Report on demonstration programme held on 19 03 2025 in front of CANARA Bank, CIRCLE OFFICE, BALMATTAROAD MANGALORE.

The programme started at 4.30 pm. Sri M R Bhat President of AIBPARC, D K Unit welcomed the dignitaries- Sri K V Acharya, President AIBPARC, and Joint Convenor of CBPRO, Sri A N Krishnamurthy, Working President of AIBPARC and President of Canara Bank Retired Officers' Association, Sri Gopinath Rao, State President of

AIBPARC, all office bearers of affiliated Associations, all the members present, the Print and Electronic media persons present, and Police personnel who were present for traffic control and for law and order maintenance. He briefly explained the need for this demonstration. He highlighted that such demonstrations were held in New Delhi, Bangalore, and other State Capitals and now being held at District headquarters. Sri A N Krishnamurthy in his brief highlighted the various agitational programmes conducted by AIBPARC jointly with CBPRO, and other Apex Retiree Associations. He then initiated sloganeering which was responded by the people present at the venue. Later Sri K V Acharya, President AIBPARC dwelt at length the struggle for pension, which was achieved in 1992-93 with retrospective effect from 1986. However, IBA/successive Governments denied Updation of pension and other benefits. Hence struggle continues to achieve the following goals- Updation of pension, implementation of Regulation 35 - 1, affordable health insurance for all retirees, reckoning special allowance for calculation of pension, negotiating status for all major Retiree organisations etc. He also highlighted the M C Singla case in Supreme Court and outcome is being awaited. He called upon to members to be ready for any call for further agitational programme. Sri Gopinath Rao, State President of AIBPARC, also spoke on the occasion and highlighted the struggle for various demands of Retiree organizations. Later Sri A N Krishnamurthy initiated sloganeering which was well responded by the members gathered.

The programme concluded with vote of thanks by Sri K N Shankar, general Secretary of Corporation Bank Retired Officers' Association. He thanked Sri K V Acharya, Sri A N Krishnamurthy, Sri Gopinath Rao, all the office bearers of affiliated Associations, all the members for their presence, the media for their coverage of the programme, and department of police for their arrangements for traffic control and law and order control.

9. Names and mobile numbers of TPA officials to be contacted in case of urgency &
10. Names and mobile numbers of CBROA local Leaders to be contacted
