## FROM THE DESK OF GENERAL SECRETARY



## Dear Members/,Associate Members.

The IBA and UFBU have decided discussions to commence on implementation of Group Mediclaim Policy for the Bank retirees and in-service employees for the ensuing year. The Retirees' Organisations including our apex body AIBPARC had represented to the IBA and Government to extend reimbursement of medical expenses to retirees also as in the case of serving employees. Our argument is based on the fact that

the retired employees of Central Government, Railways, Defence forces besides many public sector undertakings are enjoying the facility. During the previous year the IBA agreed to bring the serving employees and retirees under one health insurance policy. This resulted in floating a Group Mediclaim Policy at a very affordable premium for the retirees. Our Bank mitigated the pensioners hardship of by subsidizina the Insurance premium to the extent of Rs 6,000/- per pensioner.

gesture from The small the Management of our Bank notwithstanding, IBA has violated the directive issued bv the Department of Financial Services, Ministry of Finance vide their letter No F No.14/7/92-II(Vol II) dated 24.02.2012 addressed to IBA which states as per its essence that, it should be one Policy and premium is to be paid by the respective banks for both serving employees and retirees from their respective Welfare Fund, instead of reimbursing cash. A common policy was floated but the premium for the serving employees was absorbed by the bank and the premium in case of retirees was to be borne by the retirees themselves out of their meagre pension which is not revised or updated since 1995 inspire of several representations to the IBA and Government of India.

When the Scheme was introduced IBA advocated and convinced the poor retirees that the scheme was the best one with lower, affordable premium. But later we realised that the premium on the policy increased exorbitantly, step by step, over the years, compelling a large number of retirees to opt out of the policy as they could not just afford the burden of the premium amount. Coupled with this the Domiciliary treatment facility with Super Тор Up policy for reimbursement cost of of

medicines, the retirees had to pay unjustifiably high premium. The Domiciliarv treatment reimbursement was restricted to 10% of the insured amount as against the exorbitant premium amount. This had no rationale or premium the for logic as reimbursement of expenses incurred for domiciliary treatment was far in excess of the amount to be reimbursed

Adding fuel to the fire, levying 18% GST on the premium amount has made the policy more unaffordable. The increased premium rates, especially in higher age group forces the senior retirees to choose the exit route.

Contrary to the common belief that the Group Mediclaim Policies are cheaper compared to retail policies, the Insurance Companies have been resorting to hike in premium rates on an ad-hoc basis on the pretext of ever-increasing medical costs and thus making the Group policy unaffordable.

The adverse Net Incurred Claim Ratio (NICR) I e the excess amount paid over the premium amount received in a year is the chief argument of the insurers for a hike in premium. The NICR crucially depends on number and amount of claims while the percentage of claims to total policy remains the same, contrary to this the claim amount has been on the

rise due to reported increase in service costs of the hospitals. This aspect needs to be revisited as uniformity there is no and among the transparency networked hospitals with regards to treatment of ailments and thereof. The charges nexus between networked hospitals and Third Party Agents (TPAs) is also to be looked into while examining the reasons for escalation in hospital costs.

### NEED OF THE HOUR.

The important components of cost of Health Insurance Policy are claims, operating expenses and taxes. On implementation of GST regime, the tax component has increased from 15% to 18% which is a big burden on the retirees. Health care being the priority on the Government agenda, taxing the retirees is not fair. Government need to revisit their stand on levying GST on Health Insurance premium and initiate steps to bring down GST to zero.

The argument of the Insurance companies is that they are forced to hike the premium on account of increased claims coupled with medical inflation. Since the policy holder base is broadened by covering the serving employees and retirees, naturally the number of claims will be on the rise. The adverse claim ratio as reported by the Insurance companies is not on

account of increased number of cases but high value claims. The principal reason for this is not having uniform rates for each ailment/disease and the treatment from cost varies hospital to hospital within а city /town. Further, it is a well-known fact that the Health Card Holder will be charged more compared to normal cash payment, by the Corporate Hospitals. Thus, monetary cap on ailments and uniform billing with health card or without health card is the need of the hour.

The IBA and UFBU have been urged to keep the above facts in mind while having a discussion on the Group Mediclaim Policy for the serving employees and retirees, to be floated for the ensuing year. Our apex body AIBPARC has been relentlessly campaigning for absorption of the premium amount by the Bank.

Life is full of uncertainties but "Ageing" us certain. Each one of us invariably undergoes the cycle and finally joins the super senior category. Consequently, the age related ailments will be the order of the day and these need to be addressed suitably.

The retirees of Banking Industry are known for their hard work, sacrifices, dedication and devotion to the organisation's goals and objectives and their contribution to the nation building is invaluable. It is not out of place to mention that the retirees of Banking industry are the most law -abiding citizens and have been genuinely paying taxes all through their service. "RESPECT ELDERS" though has resonance in various forums but very little is done in letter and spirit. We are forced to look up to the Government and our beloved Bank not for any freebies or charity but for a deserving health coverage to continue our journey in our twilight years with peace and dignity.

We wish our members health, happiness and a joyous time for all the days ahead.

The meeting was concluded with vote of thanks and National Anthem.




#### JHARKHAND

Oh, Unknown Creator, Divine, Let nothing be mine, still it's fine, As long You accept me, as Thine, As long as I belong to Thine.


### PROJECT PATIENCE

#### Book Review By Laxman Gorlakatte, Mem No 2902 "THE GOLDEN YEARS; THE MANY JOYS OF LIVING A GOOD LONG LIFE." Author: RUSKIN BOND

Publisher: Harper Collins Publishers India, Pages: 154, Price: Rs. 399

This book is by Ruskin Bond, one of India's most popular writers. Born in 1934 Ruskin Bond grew up in Jamnagar, Shimla, New Delhi and Dehradun and a short stint in UK. He has authored novels, short stories, poetry, essays, anthologies and books for children. He received the Padmashri (1999) and Padma Bhushan (2014) and a Lifetime Achievement Award by Delhi Government in 2012.

As a prelude to the book he writes "This book is about growing old and liking it. It may be helpful to those entering their sixties, seventies and eighties. It might even be of interest to young people who don't believe they will ever grow old. They will, if they are lucky. So prepare for what is truly the best time of your life". Interestingly the book is divided into 60 essays. Sixty is when one is bestowed with the title 'Senior Citizen'. Through these absorbing essays, Ruskin Bond shares many joys, which make up living a good life. As we grow old we are bound to be hampered by health issues. But one must continue with work, be it for a pleasure or profit. There are so many who do not allow the advance of age to deter them from their creative pursuits or for their willingness to work for the betterment of human race' points out the author. The human brain is at it's most fertile in our later years, when there is lifetime of experience at our creative disposal. No surprise, he has authored this book when he was well over eighty vears. He finds that there is so much beautiful and worthwhile in this world. Nature's seasons; Sun rise and Sun set; night and day; sunshine and rain; the earth's green cover: the wealth of our forests, rivers and oceans to name a few. And human kindness, fortitude, the creative spirit, all of which come free, but are priceless. He calls upon us to look at everything as if one is seeing them for the last time. This thought will make one appreciate them all the more.

He loves Reading, Writing, walking, watching Nature and enjoying his breakfast. What keeps him away from worries is his 'laugh it away' approach to criticism and troubles of life. His love for reading comes to the fore when he says that he is more a reader than a writer. Having started reading at a young age of ten, he has been reading one book a week, sometimes two or three. Reading has been always his niche pastime.

He has some advice to writers. 'If no one enjoys your writing, never mind, you have done it for yourself and your own pleasure'. He recalls that when he wrote his first novel "The Room on the Roof", it was rejected by publishers. When he had lost all hopes, Aundre Deutsch a publisher chanced upon the manuscript and published it in 1954. The book bagged the prestigious John Llewellyn Rhys Award in 1957. From there on, there was no looking back in his long journey of writing, spanning over six decades with more than 170 publications. Perseverance paid off!

Watching nature is a favourite pastime for the Author. The great wide beautiful world that is there for all of us to marvel at. And how? By using all the five senses we are bestowed with. Our eyes are windows to the world and all the wonders of creation. We hear too; the sounds of nature, the wind, rain and the 'gossip' of birds. Great music and so much to hear from loved ones and enjoy! There is smell of mountain air, sea breeze or fragrance of flowers. We smell and enjoy good food too. The sense of taste! There is so much to taste; chocolates, chips and fish! With taste our taste buds keep going

making life worth living! And then there is the touch. The touch of a loving hand. He feels that one has to be more aware of the five senses. Why not appreciate all that the world has to offer through our senses!

"I have been a great walker for the better part of my life" writes the Author. He loves to walk leisurely, not in a hurry. He would like to stop by on his way to enjoy the scenery or to talk to passers-by. A long walk will always take you somewhere-and you will discover others as well as yourself. "Wherever you are, try walking your blues away" and "Get out of the house. The song of bulbul is preferable to the squeak of the mouse" he urges. Reading and Walking have been his sure remedies to drive away loneliness.


All sixty essays are short and crisp, which are just one or two minutes of reading. As one starts reading, the author appears to be in straight conversation with the reader. The simple and beautiful prose beholds the reader. Throughout, the author is warm, witty and whimsical putting life into words.

An attempt at doing a chapathi which ended in a shape of India map, his savouring a bun by buttering and stuffing with mango chutney at odd hours of night to satisfy his hunger pangs and calling the two cut slices of bun as Laila -Majnu or Romeo- Juliet reveal his sense of humour.

The book can be read in one go or one could dip into any part randomly and repeatedly without slightest feeling of repetition.

Ruskin Bond sums up "These are our golden years. As we enter our seventies and eighties, we find ourselves arriving at a better appreciation of all that is worthwhile in our planet and in this world of our making"

One is reminded of the lines, "Grow old along with me! the best is yet to be, the last of life, for which the first was made" by Robert Browning. Old or Young, this book inspires every one.




