FROM THE DESK OF GENERAL SECRETARY



Dear Members/Associate Members,

BANK NATIONALISATION DAY

Come the month of July every year we become nostalgic about Nationalisation of Banks in the year 1969. 56 years ago on July19, 1969 the then Government nationalised 14 large private commercial banks through the Banking Companies (Acquisition & Transfer of Undertakings) Ordinance 1969. Likewise, in the second phase on April 15 1980, six more private Banks with a capital base of Rs.200/- crore were nationalised. With this 90% of the Banking Sector came to be wholly owned by Government of India.

Till 1968 all the private banks in India were confined to big cities only. All of them were monopolized by industrial houses with the share of industry in credit disbursal by private banks doubling between 1951 and 1968 from 34% to 68%, while agriculture the backbone of our economy was receiving less than 2% of the total credit. India being basically an agrarian economy,

agriculture sector needed capital infusion, with the initiation of Green Revolution in India that aimed to make the country self-sufficient in food security.

As the banks were owned and managed by the private owners the services of the banking industry had a narrow reach - the masses had no access to the banking services.

The Government needed to direct the resources in such a way that greater public benefit could take place, Nationalisation of banks paved the way out.

The planned development of the country required a certain degree of government control on the capital generated by the economy.

Other reasons that necessitated the Nationalisation were, social welfare, controlling private monopolies, expansion of banking to rural areas, removing regional imbalances and rural-urban divide.

Nationalisation of banks led to removal of social, economic or political barriers between bankers and customers. This resulted in a massive quantitative expansion in the customer base and helped improve the services.

This enabled the banks to widen their reach. The banks embarked upon a massive expansion programme by opening branches in hitherto unbanked areas. With this the economy also expanded and employment opportunities were created even in the remote corners of the country. Expansion of branch network witnessed rise in the number of branches from 7219 in 1969 to more than 86,000 branches today.

This accelerated the process of development of the priority sectors of the economy viz small scale industries, small business enterprises, village artisans etc which were not getting any attention from the commercial banks. Agriculture and allied sectors viz dairy farming, pisciculture, poultry farming etc emerged as the largest contributors to the national income.

Nationalisation helped the bank branches to mobilise savings of the people to a great extent and utilise them for economic development.

It is the Public Sector Banks which have supported the Central Government's poverty alleviation programmes. Opening of Jan Dhan

Accounts has brought more than 30 crore families within the ambit of the Public Sector Banks.

All the foregoing factors contributed immensely to achieve self-sufficiency in food grains, milk production.

But the step had its negative side also.

Even though the Public Sector Banks' reach has increased across the country, many parts of the country have remained unbanked. This was due to lack of competition.

With Nationalisation banks were brought under the control of the Government which led to political interference and pressures thereby hampering professionalism. Many Public Sector banks badly suffered due to political interference and populist policies of the Government. During 1970's and 80's political interference and populist policies were seen in arranging massive loan melas which resulted in huge non-performing assets. Even today the Public Sector Banks are grappling with huge amount of NPAs.

Huge expansion in branch network, large staff administrative expenditure led to increased expenditure and consequently reduction in the profitability of the Banks.

After introduction of Prudential norms, the Public Sector Banks had to undergo a traumatic experience. But still the Public Sector Banks waded through the rough waters and continued to perform well.

The impact of Nationalisation is believed to be greater than the economic reforms of 1991.

But the present Government is emphasising on the privatisation of Public Sector Banks but it is not hidden from anyone how the Private and Public Sector Banks have performed in times of crisis, including the Covid-19 pandemic.

We have resisted the privatisation move of the Central Government and hence, the move is kept on hold. But the merger of Public Sector Banks had taken place reducing the number of Public Sector Banks to 12. The Government should not rush with the privatisation of Banks, rather should focus on comprehensive governance reforms, because if the Banking

Sector is run by independent boards and in a dynamic manner then Public Sector Banks also can work like any other Private Sector Banks.

We are proud that we were part of this glorious saga and we vow to continue our struggle for retention of the Public Sector character of the Banks

We wish all our members /Associate members a happy, healthy, joyous time for all the days ahead.

Summary of AIBPARC Governing Council Meeting (Chennai, 11 June 2025)

Dear Comrades,

The 5th Governing Council Meeting of AIBPARC (2023–2026 term), held in Chennai, was a decisive gathering marked by spirited deliberations, deep concern for long-pending issues, and a firm commitment to intensify our movement. The leadership, affiliates, and members from across the country, including active participation of CBROA, reasserted their collective resolve.







The key focus of the meeting was the long-overdue pension updation, health insurance, special allowance exclusion, issues of VRS optees, resignees, and denial of ex-gratia. The leadership acknowledged the legal delays and reaffirmed the need for a parallel agitational path along with legal remedies.







Major Decisions & Action Plan:

- ♦ Legal Follow-up: Continued active support to the pending legal cases in Supreme Court (MC Singla Case) and High Court (ARISE) with close coordination by our Legal Assistance Team.
- ♦ Nationwide Hunger Strike Programmes: State Committees to hold day-long Hunger Strikes with a public meeting in July 2025. A centralised Hunger Strike at New Delhi is to follow in August/September 2025.

All actions will be carried out jointly with CBPRO constituents to reinforce strength and visibility.

- ♦ Consistent Engagement with Stakeholders: The leadership is in active dialogue with UFBU constituents and has appealed for their support to Retirees' issues.
- Organisational Strengthening:

Reactivation and support to dormant State Committees and enhanced use of digital tools for better communication and mobilisation.

In a side-line interaction, he called upon retired bankers to act as mentors for the youth, helping build their skills for better employment prospects.

Each Dindi:

- Represents a group of devotees from a region.
- Is assigned a number and place in the Palkhi procession.
- Has its own flag bearers, drummers, and seva coordinators.

Over 6 to 8 lakh Warkaris walk approximately 250 km over 21 days to reach Pandharpur, making this one of the largest foot pilgrimages in the world, recognized by the World Book of Records.

Spirit of the Wari

The Wari is more than a journey — it is a celebration of faith, unity, and devotion. Saffron flags wave in harmony, veenas and mridangams fill the air with music, and women carry sacred pots with tulsi, all while chanting "Dnyanoba-Tukaram" in unison.

Which is the real and which is fantasy, we fail to recognise, Everything appear to be meaningless, helplessly we surmise.




