FROM THE DESK OF GENERAL SECRETARY



Dear Members and Associate Members,

We met a senior colleague sometime back and found that he is in good health but we could see streaks of pain and pathos on his face. His conversation with us revealed the fact that he is leading a lonely life with his wife. He was pouring out his heart talking about his two sons and their achievements in their professional career in foreign land. The couple in their evening of Life are leading their life with the help of some assistants. We asked him how often his children come to India to see their parents, he slipped into silence and he never answered our question. We ascertained from other sources that his children rarely visit their parents. They have been insisting the couple to go and stay with them in foreign land. But the couple want to live on their own without putting any burden on anybody including their children. It is a sad story that in the evening of his life none of the children or their families care for them or support them.

This incident made us to reflect on the conditions of the elderly in our society a few decades back. There was a time when the elderly was revered in India as symbols of tradition, respect, wisdom, knowledge and experience. The elders controlled and guided the destinies of all the members of the joint family. Urbanisation and industrialisation has led to the breaking up of the joint family system. The disintegration of joint families has had an adverse impact on the elderly people, especially in the rural areas. Many elderly people get neglected because of the emergence of nuclear set up of families. The aged are now viewed as useless and non-productive entity. Modernisation has led to the degradation of their status and authority. Their existence as integral part of the family is now uprooted. With the decline in their functional position as head of the family they have lost their authority, respect and prestige they used to command earlier.

The changing values and the dependence of the aged on their sons and daughters-in-law has complicated the problems. The aged are marginalised, alienated and left out of the mainstream. Neglect, lack of respect, verbal taunts, interactional stress and increasing gap in communication make the aged feel unwanted and unpleasant entities. The only peaceful place for these weak, sad and depressed people in the evening of their life are, the homes for the aged. In the backdrop of this unfortunate development, the need for old age homes has certainly increased and old age homes have become the refuse for the elderly to lead a peaceful and happy life among those who share and care for them.

Fortunately, our retired colleagues are having the comfort of financial security by way of monthly pension. Most of these retirees belong to middle income group and are capable of weaving safety nets to take care of their health and physical existence. Because of lack of support from children and other family members, they dulk in themselves, curse at their fate, muse at their helplessness and blame others for their current status. It is pertinent to note here that most important thing in this stage of life is health and facing health issues including physical pain, memory decline and an increased risk of conditions like depression or anxiety.

The only way out is embracing the hard realities of life as they come. Let us be realistic. The period of joint family as a safety net is over. It is high time for all of us to join with peer groups and build safety nets for the evening of life.

We are on the threshold of another New Year. The year 2025 is coming to an end but its memories will forever be etched in our hearts as we journey into the New Year 2026. We wish all our members and Associate Members a Merry Christmas. May Christmas bring joy to your heart and happiness to your home.

Forgive, forget and heal, to replenish your own fair health, Only Divine and none else, can be perfect on this earth.




BLESSED ARE THOSE


